



Please note that this constitutes a Notice of Determination of Liability of Ordinance XXX of the Municipal Code of the Village of Orland Park, IL. Pursuant to such Ordinance, the owner of the motor vehicle is liable for payment of a civil penalty in the amount of \$100.00 if the owner's vehicle enters an intersection monitored by a photographic traffic signal enforcement system against a red light in violation of Illinois law. Recorded images are evidence of a violation of a red light enforcement system. As you have failed to pay or contest the Notice of Violation previously issued, a fine in the amount of \$100.00 is now due.

Failure to pay the civil fine or to petition the Village to set aside the determination within (30) calendar days, will result in a Notice of Final Determination. In addition, you may be subject to formal collection procedures including, but not limited to, being reported to a credit reporting agency, and a civil lawsuit.

TO CHALLENGE THIS NOTICE OF DETERMINATION:

Should you choose to do so, you are entitled to contest this Notice of Determination and to request an administrative hearing via a Petition to Set Aside the Determination. Such Petition must be submitted in writing within 14 days of the mailing date noted on the front of this notice. Once submitted, a Hearing Officer shall determine whether sufficient cause has been shown to schedule a hearing. Please note that the grounds for the Petition must assert a valid defense as defined in the Ordinance.

Valid Defenses Include:

- The vehicle or its registration plates were stolen prior to the infraction. Must include Police Report Number.
- The driver passed through the intersection in order to yield the right-of-way to an emergency vehicle.
- The vehicle was sold or ownership transferred prior to the violation occurring.
- The Registered Owner is a Fleet Vehicle owner/operator/lessee, or an enterprise engaged in the sale, lease or rental of motor vehicles. (see below)
