LOT 7 (EXCEPT THAT PART THEREOF LYING WEST OF A LINE 50 FEET OF THE WEST LINE OF THE EAST HALF OF THE NORTHEAST QUARTER OF SECTION 11 TOWNSHIP 36 NORTH, RANGE 12 EAST OF THE THIRD PRINCIPAL MERIDIAN) IN BLOCK 10 IN WALKER'S SUBDIVISION OF THE SOUTH HALF OF THE NORTHEAST QUARTER AND THE NORTH HALF OF THE SOUTHEAST QUARTER OF SECTION 11, TOWNSHIP 36 NORTH, RANGE 12 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

PARCEL 2:
