**Storm Sewer- Pond Outlet Pipe Replacement Scope**

1. Provide and install SILT FENCE- 400 LF
2. Break out and remove existing CONCRETE GROUTED RIP RAP- approx. 15'x32'
3. Remove existing 30" CMP- approx. 32 LF
4. Provide and install 30" RCP CLIII- approx. 32 LF
5. Provide and install 30" CONCRETE F.E.S. (w toe block & grate)- 2 EA
6. Provide and install RIP RAP (RR4) w Filter Fabric- approx. 34 SY
7. Trim Existing Trees as needed- 1 LS
8. Provide and install 4" Topsoil and Sod- approx. 444 SY

1. Includes 1 – mobilization of equipment.
2. Includes hauling off uncontaminated sewer and water spoils.
3. Construction by Camco, Inc. is NOT responsible for damage or repair to unmarked or un-located private utilities
