WHEREAS, on June 27, 2011, a certain Agreement regarding Recreation Program Brochures printing between the Village and the Contractor was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, the Village wishes to modify the scope and the term of the agreement.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2. Section 2 scope of the work shall be modified to remove the Spring/Summer 2012 brochure and add on the Winter 2015 brochure. All relative deadlines shall remain the same.
3. In **SECTION 4: TERM OF THE CONTRACT:** the words "This Contract shall terminate upon completion of the WORK or July 31, 2014" shall be stricken in their entirety and replaced with "This Contract shall terminate upon completion of the WORK or December 31, 2014".
4. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
5. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

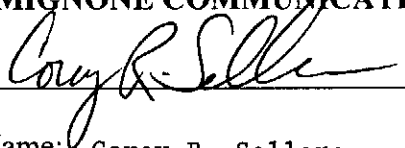
