SECTION 6-103. ZONING OF NEWLY ANNEXED LAND AND REZONING.

- A. **Annexation**. All fully developed land which shall be annexed to the Village shall be classified into the zoning district that is most compatible, in the opinion of the Board of Trustees, with the Village's Comprehensive Plan. All undeveloped or partially developed land which shall be annexed to the Village shall be automatically classified and zoned in the E-1 Estate Residence District until otherwise classified in accordance with the Village's Comprehensive Plan.
- B. **Petition For Annexation**. The owner of any land proposed for annexation to the Village shall file with the ~~Development Services Department Development Review Committee~~ a petition for annexation. The ~~Development Review Committee Services Department~~ shall review such application and shall recommend to the Board of Trustees whether such annexation should be approved. If such petition involves a zoning classification other than E-1, the petition shall be referred to the Plan Commission which shall recommend to the Board of Trustees the appropriate zoning district in accordance with the procedures of Section 5-108. If such petition involves an annexation agreement, the provisions of Ill. Rev. Stat. Ch. 24, §7-1-2, as amended, shall be followed.
- C. **Proposal for Rezoning**. If a petition or application is made requesting a map amendment to a property other than E-1, the petition goes to Plan Commission as a public hearing and shall include a site plan in its submission to the Development Services Department.
