# 2011-0094 Disposal of Certain Seized Vehicles at Public Auction - Recommended Ordinance

Police Chief Tim McCarthy reported that the police department is requesting that the Village declare two forfeited vehicles described herein as excess property and to dispose of at public auction. The vehicles were seized by the department and forfeited to the village by the Circuit Court of Cook County from drivers who were driving their vehicle while their license was suspended for DUI.

The vehicles are described as follows:

# 2011-0076 Ordinance Amending Title 6 Chapter 10 of the Village Code- Recommended Ordinance

Chief McCarthy reported that the police department is requesting to add four additional state statutes to Title 6, Chapter 10 of the Village Code that would allow for impoundment of offending vehicles as follows:

- 1) 625 ILCS 5/11-401(a); Motor Vehicle Accidents Involving Death or Personal Injury
- 2) 625 ILCS 5/11-402(a); Motor Vehicle Accidents Involving Damage to Vehicle
- 3) 235 ILCS 5/6-20; Illegal Possession Consumption of Alcohol by a Minor
- 4) 720 ILCS 5/11-9(a)(2); Public Indecency

Items one and two would be utilized when the driver leaves the scene of the accident and abandons the vehicle. Number three will be restricted to consumption violations only and four would be utilized only if the driver of the vehicle is in violation of the statute.

Trustee Gira requested that "Illegal Possession" be removed in number 3. She would like to see consumption and possession treated differently; perhaps for example possession would receive a second chance.

Chief McCarthy agreed with Trustee Gira and will evaluate Illegal Possession at a later date.

I move to recommend to the Village Board to pass an Ordinance entitled: AN ORDINANCE AMENDING TITLE 6, CHAPTER 10, OF THE ORLAND PARK VILLAGE CODE IN REGARD TO THE SEIZURE AND IMPOUNDMENT OF MOTOR VEHICLES;

and

To remove in item 3. the wording "Illegal Possession" and only have Consumption of Alcohol by a Minor.
