

REAL PROPERTY LICENSE AND ARTIFACTS AGREEMENT

This Real Property License and Artifacts Agreement (the "Agreement") is dated as of April 19, 2021 and entered into by and between the Village of Orland Park, an Illinois home rule municipal corporation ("Village"), and Orland Historical Society, an Illinois not-for-profit corporation ("OHS", and together with the Village, the "Parties").

RECITALS

WHEREAS, OHS owns two (2) historic log cabins (the "Cabins") presently located on real property owned by Village and as legally described on Exhibit A attached hereto (Village's Property"); and

WHEREAS, Village desires to grant to OHS and its officers, employees, agents and invitees, (collectively, its "Representatives") (i) a revocable, non-exclusive license to enter and use the Village's Property on the terms and conditions set forth below, and (ii) a revocable exclusive license to use a portion of the space located within the Licensed Area as depicted on the plan attached hereto as Exhibit B (the "Space Area"), representing the current locations of the Cabins; and

WHEREAS, OHS owns certain artifacts and other objects of artistic, cultural, historical or scientific importance, particularly with regard to the history of the people and places within the Village of Orland Park, some of which are currently in the possession of the Village (the "OHS Artifacts") a comprehensive listing of which is attached hereto as Exhibit C; and

WHEREAS, OHS agrees to allow Village to display the OHS Artifacts for public viewing through exhibits from time to time, which exhibits will be located in the Village of Orland Park, Illinois, and in connection therewith to promote a wider appreciation of the history of the Village of Orland Park during those times when the OHS Artifacts are not on display by the OHS.

NOW, THEREFORE, in consideration of the premises and the mutual covenants and agreements hereinafter set forth, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. **Grant of License.** Subject to the provisions, covenants and agreements herein contained, Village hereby grants to OHS an exclusive revocable license (the "Exclusive License") to use the Space Area. Village hereby further grants to OHS a non-exclusive license (the "Non-Exclusive License", and together with the Exclusive License, the "License") to use Village's Property for the purposes herein specified for the Terms, as hereinafter defined. Village and OHS agree that this agreement shall supersede any prior agreement, whether oral or written, in relation to the Licensed Area, Space Area, and/or OHS Artifacts.

2. **Term.** The term of the License shall be annual (the "Term") with a one-hundred eighty (180) day notice to be given by either OHS or Village when terminating this Agreement. The Term of this Agreement shall automatically renew annually unless a one-hundred eighty (180) day termination notice is given by either OHS or Village.

3. **Termination.** In addition to any and all other rights or remedies provided in this Agreement or which Village may have at law, in equity, or otherwise, in the event that OHS fails to comply with any obligations imposed upon OHS hereunder, Village shall have the right, after thirty

(30) days written notice to OHS of any such non-compliance and OHS's failure to remedy same within such period (or if such non-compliance cannot be remedied within such thirty (30) day period, OHS's failure to commence a cure within such period and diligently thereafter pursue such cure to completion), to terminate this Agreement on the date specified by Village in such notice, and OHS shall immediately vacate the Licensed Area as required hereby. At the termination of the License herein granted, by lapse of time or otherwise, OHS shall remove the Cabins from the Space Area at OHS's sole cost, expense and liability leaving the Space Area and Village's Property level, flat and without any uneven grade or tripping hazards..

4. **Fee and Deposit.** In consideration of Village executing this Agreement and providing OHS with access to, and use of, the Licensed Area, and in consideration of forgoing other opportunities with other users of the Licensed Area, OHS shall pay to Village a fee of ONE DOLLAR (\$1.00) for all or any part of a year which shall commence upon execution of this Agreement (the "Fee"). The Fee is payable in advance to Village upon execution hereof and annually thereafter, at the address from time to time specified by Village. Nothing contained herein shall grant OHS the right to holdover after the Term of this Agreement (as it may be extended) has expired.

5. **No Representations; Nature of Village's Property.** OHS acknowledges and agrees that the OHS is being provided with access to, and use of, the Village's Property, and OHS shall accept the Village's Property, in its then "as is" condition as of the execution of the Agreement and OHS's occupation or use of any portion of the Licensed Area shall be conclusive evidence that the Licensed Area was in good order and satisfactory condition when OHS was granted access. Village has not made nor does Village make any representations or warranties with respect to the Space Area or the Village's Property and OHS agrees that Village does not have any obligation to perform any work or otherwise prepare the Space Area or Village's Property for OHS's use.

OHS ACKNOWLEDGES THAT THE SPACE AREA IS NOT SEPARATELY DEMISED FROM OTHER AREAS AND PREMISES ON THE VILLAGE'S PROPERTY. OHS UNDERSTANDS THAT VILLAGE'S PROPERTY IS NOT A SECURE AREA AND OHS TAKES FULL RESPONSIBILITY FOR THE SECURITY OF THE CABINS AND OHS'S PERSONAL PROPERTY. VILLAGE IS NOT RESPONSIBLE FOR THE SECURITY OF ANY OF OHS'S PERSONAL PROPERTY. VILLAGE SHALL NOT BE LIABLE FOR ANY DAMAGES OR LOSSES INCURRED BY OHS IN THE EVENT OF ANY LOSS, CASUALTY OR THEFT. VILLAGE RECOMMENDS THAT OHS ARRANGE FOR THE SECURE STORAGE AND PROTECTION OF ITS PERSONAL PROPERTY.

6. **Alterations.** OHS shall not make or cause to be made any alterations, installations, improvements, additions or other physical changes in or about the Village's Property without obtaining the prior written consent of Village with respect thereto.

7. **Repairs.** OHS, at its sole cost and expense, shall maintain and take good care of the Space Area, including the appurtenances therein. All damage or injury to the Licensed Area or to any part of the Space Area, or to its fixtures, equipment or appurtenances, whether requiring structural or nonstructural repairs, caused by or resulting from misuse or negligent conduct or omission of OHS or its Representatives, shall be repaired, at OHS's sole cost and expense, by OHS to Village's reasonable satisfaction. OHS also shall repair all damage to the Space Area and the Licensed Area caused by the installation, moving or removing of the Cabins or the Cabins or its property.

8. **Use.** OHS may use and access the Licensed Area for the exhibition of the Cabins to the general public and for no other purpose. . Subject to the terms of this Agreement, OHS shall have access to the Cabins and Licensed Area at all times (24 hour per day, 7 day per week basis), subject to force majeure. OHS shall not commit waste, subject the Licensed Area to any use which could damage the same or raise or violate any insurance coverage, permit any unreasonable odors, smoke, dust, gas, substances, noise or vibrations to emanate from the Licensed Area, take any action which would constitute a nuisance or would disturb, obstruct or endanger any others in or around Village's Property, take any action, or use or allow the Village's Property to be used for any unlawful purpose. Village may use and access the Cabins for the exhibition of the Cabins to the general public subject only to coordination of timing and event scheduling with OHS.

9. **Requirements of Law.** OHS, at its sole cost and expense, shall comply with all present and future laws, rules, orders, ordinances, regulations, statutes, requirements, codes and executive orders, extraordinary as well as ordinary, of all governmental authorities now existing or hereafter created, and of any and all of their departments and bureaus, or other body exercising similar functions, affecting the Cabins.

10. **Service.** The Village agrees that it shall continue to provide electrical service to one of the Cabins, but OHS acknowledges and agrees that Village shall have no obligation to provide electrical service to the second Cabin nor any other public utility, security or communication service to either Cabin. If any such service is desired by OHS, OHS shall secure and pay for its own such service.

11. **Insurance.** OHS shall obtain and shall keep in full force and effect a policy of comprehensive public liability (including coverage for bodily injury, property damage, and personal injury (employee and contractual liability exclusions deleted), contractual liability, owner's protective liability and broad form property damage) with (i) OHS named as the insured thereunder and (ii) Village named as additional insured thereunder. Such insurance shall include coverage for OHS's indemnification obligations hereunder. The minimum limits of liability under such policy shall be a combined single limit of not less than One Million Dollars (\$1,000,000) with respect to each occurrence, and Three Million Dollars (\$3,000,000) aggregate liability limit. Such policies of insurance shall be issued by an insurance company licensed to do business in Illinois. If any such insurance policy provides for a deductible, the deductible shall not exceed \$1,000. OHS shall deliver certificates of said insurance to Village prior to OHS's occupying the Space Area, said certificates to provide that thirty (30) days' prior notice shall be given to Village in the event of cancellation or non-renewal. All insurance maintained by OHS shall be on a primary and non-contributory basis to any insurance provided by Village. The limits of such insurance shall not, under any circumstances, limit the liability of OHS hereunder. OHS, on its behalf and on behalf of its insurer, hereby waives all rights of subrogation with respect to Village.

12. **Non-Exclusive Use.** The Non-Exclusive License granted hereunder is expressly non-exclusive and neither the payment of any amounts hereunder by OHS nor any other provision of this Agreement shall impair in any way Village's rights or ability to negotiate with any person with respect to the use by such person of the Village's Property, except to the extent of the rights specifically granted to OHS hereunder, including but not limited to those pursuant to the Exclusive License.

13. **Assignment.** Village shall not assign or sublicense its rights or delegate its duties under this Agreement (whether by operation of law, transfer of interest in OHS or otherwise).

14. **Waiver of Jury Trial.** OHS and Village hereby waive trial by jury in any action, proceeding or counterclaim brought by either of OHS or Village against the other on any matters whatsoever arising out of, or in any way connected with, this Agreement. If Village commences any summary proceeding against OHS, OHS shall not interpose any counterclaim of whatever nature or description in any such proceeding. Moreover, OHS shall not seek to consolidate such proceeding with any other action which may have been or may be brought in any other court by OHS.

15. **Access.** OHS acknowledges and agrees that Village and its respective officers, employees and agents shall have the right, from time to time throughout the Term, to enter any portion of the Village's Property to examine the same, and to make such repairs, alterations, improvements or additions as Village may deem necessary or desirable to the Village's Property (or any other portion of the thereof), including, structural modifications, or, with respect to Village, to make repairs or perform any work which OHS is obligated to make or perform under this Agreement, at OHS's sole cost and expense, which Village is entitled to make or may elect to perform following OHS's failure to so repair or perform. None of the foregoing shall give rise to any liability on the part of Village. Any work performed or inspections or installations made pursuant to this Section 15 shall be made with reasonable diligence and in a manner designed to minimize interference with OHS's use of the Village's Property.

16. **Ingress and Egress in OHS's Licensed Area.** OHS understands that Village, its officers, employees and agents, shall be permitted to pass through the Village's Property at any time and to make use of the Village's Property for any purpose Village deems appropriate so long as there is no unreasonable interference with OHS's access to the Space Area. OHS understands that Village may, from time to time, alter the path and routing to access the Space Area, but will, at all times, maintain access to the Space Area, subject to force majeure.

17. **End of Term of the License.** Upon the expiration or earlier termination of the Term of the License, OHS shall vacate the Licensed Area, in good order and condition, ordinary wear and tear excepted, and OHS shall remove the Cabins and all of its property therefrom. OHS acknowledges that occupation and use of the must cease upon the expiration or earlier termination of this License. The provisions of this Section shall survive the expiration or earlier termination of the Term of this License. If OHS fails to fulfill its obligations under this Section 17, Village shall have the right, in its sole discretion and without prejudice to any other remedy it may have under this Agreement or at law, or so much thereof as necessary, to satisfy OHS's obligations under this Section at OHS's sole cost and expense. The Village acknowledges that in the event that this agreement is terminated and the Cabins are removed from the Licensed Area, OHS would, most likely, seek to relocate them to the Humphrey House property and the Village is committed to working with OHS, to the extent practicable, to secure the necessary zoning approvals to do so.

18. **Limitation of Liability.** Village's obligations under this Agreement shall not be binding upon Village after the sale, conveyance, assignment or transfer by Village of its interest in the Village's Property and in the event of any such sale, conveyance, assignment or transfer, Village shall be and hereby is entirely freed and relieved of all covenants and obligations of Village hereunder; provided that such sale, conveyance, assignment or transfer occurs after the first full term of this Agreement. None of the Village Parties or OHS Parties (as defined in Section 24) shall be liable for the performance of Village's or OHS's obligations, respectively, under this Agreement. OHS shall look solely to Village

to enforce Village's obligations hereunder and shall not seek any damages against any of the Village Parties, and vice versa.

19. **Notice.** Any notice or other communication required or permitted to be given hereunder shall be in writing and shall be deemed to have been duly given to any party (i) upon delivery to the address of such party specified below if delivered in person or by courier, or if sent by certified or registered mail (return receipt requested), postage prepaid, (ii) upon dispatch if transmitted by telecopy or other means of facsimile, in any case to the parties at the following address(es) or telecopy number(s), as the case may be:

or to such address (es) as any party may designate by written notice in the aforesaid manner.

20. **Governing Law/Amendments.** This Agreement shall be governed by and construed in accordance with the laws of the State of Illinois and may be amended or otherwise modified only by a written instrument duly executed by Village and OHS.

21. **Liens.** OHS shall permit no liens to be filed or recorded against the Village's Property or the Space Area by any supplier, laborer, contractor, or merchant with respect to services, labor or material contracted for or obtained by OHS. OHS shall hold Village harmless from and against all expenditures, disbursements or costs incurred by Village as a result of, or related to, any such lien or any notice of intent to file such a lien. For purposes of this Section 21, the filing or recording of a notice of intention to file such a lien shall be deemed to be the filing or recording of a lien.

22. **Indemnity.** Except as set forth in this Section 23 and to the extent not prohibited by law, Village, its officers, employees, agents, and independent contractors (collectively, the "Village Parties") shall not be liable for any damage either to person or property or resulting from the loss of use thereof, which damage is sustained by OHS or by other persons claiming through OHS. OHS shall indemnify, defend, protect and hold harmless Village Parties from any and all loss, cost, damage, expense and liability (including, without limitation, court costs and reasonable attorneys' fees) incurred in connection with or

arising from any cause related to OHS's occupancy of the Village's Property and occurring in, on or about the Village's Property or any acts, omissions or negligence of OHS or any other person claiming by, through or under OHS and its respective affiliates, officers, members, agents, employees, and independent contractors (collectively, the "OHS Parties"), in, on or about the Village's Property or Space Area, either prior to, during or after the expiration of the Term, provided that the terms of the foregoing indemnity shall not apply to the gross negligence or willful misconduct of Village or the Village Parties. Should any Village Party be named as a defendant in any suit brought against OHS in connection with or arising out of an event covered by the foregoing indemnity, OHS shall pay to Village or such Village Party its costs and expenses incurred in such suit, including, without limitation its actual professional fees such as appraisers', accountants', and attorney's fees. Further, OHS's agreement to indemnify Village Parties pursuant to this Section 23 is not intended and shall not relieve any insurance carrier of its obligations under policies required to be carried by OHS pursuant to the provisions of this Agreement, to the extent such policies cover the matters subject to the parties' respective indemnification obligations; nor shall they supersede any inconsistent agreement of the parties set forth in any other provision of this Agreement. The provisions of this Section 22 shall survive the expiration or sooner termination of this Agreement with respect to any claims or liability occurring prior to such expiration or termination.

23. Hazardous Substances Indemnity; Prohibited Substances.

A. **General.** OHS covenants and agrees that OHS shall conduct its activities on the Village's Property and Space Area in compliance with all applicable Environmental Laws (as hereinafter defined) and further covenants that neither OHS nor any of the OHS Parties shall use, bring upon, transport, store, keep or cause or allow the discharge, spill or release (or allow a threatened release) in each case of any Hazardous Materials (as hereinafter defined) in, on, under or from the Village's Property or Space Area. Without limiting any other indemnification obligations of OHS contained herein, OHS hereby agrees to protect, indemnify, defend (with counsel acceptable to Village) and hold harmless the Village Parties from and against any and all Losses and Claims (including, without limitation, (i) reasonable attorneys' fees, (ii) liability to third parties for toxic torts and/or personal injury claims, (iii) fines, penalties and/or assessments levied or raised by any governmental authority or court, and (iv) assessment, remediation and mitigation costs and expenses and natural resource damage claims) arising out of, resulting from or connected with any Hazardous Materials used, brought upon, transported, stored, kept, discharged, spilled or released by OHS, any member of the OHS Parties or any other person or entity (except for any person or entity which is an Indemnified Party) in, on, under or from the Village's Property or Space Area. For purposes of this License Agreement, the term "**Hazardous Materials**" shall mean all toxic or hazardous substances, materials or waste, petroleum or petroleum products, petroleum additives or constituents or any other waste, contaminant or pollutant regulated under or for which liability may be imposed by and Environmental Law. "Environmental Laws" shall mean all federal, state and local environmental laws, statutes, regulations, ordinances, and other requirements (including common law) regulating or imposing standards of care with respect to the handling, storage, use emitting, discharge, disposal or other release of Hazardous Materials, including, but not limited to, the Resource Conservation and Recovery Act of 1976, 42 U.S.C. §§ 6901 et seq., the Clean Air Act, 42 U.S.C. §§ 7401, et seq., the Federal Water Pollution Control Act, 33 U.S.C. §§ 1251, et seq., the Emergency Planning and Community Right to Know Act, 42 U.S.C. §§ 1101, et seq., the Comprehensive Environmental Response, Compensation and Liability Act of 1980, 42 U.S.C. §§ 9601 et seq., the Toxic Substances Control Act, 15 U.S.C. §§2601, et seq., the Oil Pollution Control Act, 33 U.S.C. §§2701 et seq., any successor statutes to the foregoing, or any other comparable local, state or federal statute or ordinance pertaining to protection of human health, the environment or natural resources, including without

limitation the preservation of wetlands, and all regulations pertaining thereto, as well as applicable judicial or administrative decrees, orders or decisions, authorizations or permits.

B. **Notice of Violation/Release.** OHS shall provide Village with prompt written notice upon OHS's obtaining knowledge of the existence of any Hazardous Materials on, in or under the Villages' Property or Space Area in violation of Environmental Laws, or of any potential or known release or threat of release of any Hazardous Materials affecting the Leased Premises.

C. **Survival.** This Section shall survive the expiration or other termination or expiration of this Real Property License Agreement.

24. **Reservation of Rights to Evict.** Village expressly reserves any and all right to recover the Village's Property and Space Area, or institute unlawful detainer proceedings, as Village deems appropriate in its sole discretion, at any time after the expiration of the Term for OHS's occupation of the Village's Property and Space Area, and OHS shall remain liable for all actual damages provided in this Agreement whether or not Village elects to recover the Village's Property and Space Area in any manner permitted at law, in equity, or under this Agreement.

25. **Lost Keys.** If at anytime OHS loses any key to the Cabins, OHS shall be responsible for paying any and all costs incurred to change the locks.

26. **Rules and Regulations.** OHS will abide by the following rules and regulations:

- A. OHS shall not install any sign, placard, picture, advertisement, name or notice on any part of the outside of the Cabins without the prior written consent of Village. The Village agrees to replicate, to the extent practical, and replace the signs which were previously removed from the cabins by Village, at Village's sole expense.
- B. OHS shall exclusively provide for all cleaning and janitorial services for the Cabins and Space Area.
- C. If OHS requires telegraphic, telephonic, burglar alarm or similar services, it shall first obtain, and comply with, Village's instructions in their installation.
- D. OHS shall comply with all safety and fire protection procedures and regulations established by Village or any other governmental agency.
- E. OHS assumes any and all responsibility for protecting the Cabins and Space Area from theft, robbery and vandalism, which includes keeping doors locked as well as other means of entry to the Cabins.
- F. Village, with the consult of OHS, reserves the right to make such other and reasonable rules and regulations as, in their judgment, may from time to time be needed for safety and security, for care and cleanliness of the Cabins and for the preservation of good order therein, OHS agrees to abide by all such rules and regulations hereinabove stated and any additional rules and regulations which are adopted.
- G. OHS shall be responsible for the observance of all of the foregoing rules by OHS's employees, agents, members, invitees and guests.

H. These rules and regulations are in addition to, and shall not be construed to in any way modify or amend, in whole or in part, the terms, covenants, agreements and conditions of this Real Property License Agreement.

27. **Partial Invalidity.** If any one or more of the terms, provisions, promises, covenants or conditions of this Agreement shall to any extent be adjudged invalid, unenforceable, void or voidable for any reason whatsoever by a court of competent jurisdiction, each and all of the remaining terms, provisions, promises, covenants and conditions of this Agreement shall not be affected thereby, and shall be valid and enforceable to the fullest extent permitted by law.

28. **Entire Understanding.** This Agreement and the agreements referred to herein constitute the entire understanding and shall not be changed, altered, modified or discharged, except in writing consented to by all parties.

29. **OHS Artifacts.** The Parties acknowledge, understand and agree that with respect to the OHS Artifacts that were or are located in the Cabins, or that were or are otherwise are owned by OHS, as follows :

- a. OHS on behalf of itself, its successors and assigns does hereby covenant and agrees, to waive, release and hold the Village and the Village's former, current and future officials, Board of Trustee members, officers, servants, employees, agents, volunteers successors and assigns, both in their capacities as Village representatives and as individuals, harmless from and against any loss, actions, responsibilities, obligations, liability, damage (whether direct or consequential), expenses, claims (whether asserted or unasserted, direct or indirect, existing or inchoate, known or unknown, having arisen or to arise in the future), suits, or proceedings arising under or relating to any damage or destruction to, or disposal of any OHS Artifacts, or any one of them, for any acts or omissions taken up to the date of this Agreement. The provisions of this sub-section shall survive the expiration or earlier termination of the Term of this License.
- b. The OHS and Village have jointly identified and catalogued the OHS Artifacts
- c. OHS shall allow Village, to display any of the OHS Artifacts not then being displayed by OHS, by mutual agreement, but Village shall have the final decision on the arrangement of all Village exhibits and displays and reserves the right to reject any or all parts of an exhibit or change the manner of display. The Village does not accept responsibility for ensuring that all points of view are represented in any single display. Village reserves the right to remove any Village display at any time for any reason.
- d. If the Village displays one or more of the OHS Artifacts, the Village will acknowledge that it is on loan from the OHS as part of the display but the display of OHS Artifacts does not imply Village's endorsement of an display's content; nor will the Village accept responsibility for the accuracy of statements made in such materials or the display and the Village reserves the right to post appropriate disclaimers to accompany the display materials.

- e. OHS gives Village permission to allow the OHS Artifacts to be included in any motion picture, television production, photographs and/or still photo shoots and hereby grants to the Village the right to use any photographs, pictures and recordings of the OHS Artifacts for publication and use as the Village deems appropriate. In addition, the OHS gives permission to the Village, to exhibit all or any part of film or photographs throughout the world provided that all aforementioned uses, credit is provided to OHS for ownership of the OHS Artifacts.
- f. The Village agrees to offer storage for any of the OHS Artifacts that neither OHS nor the Village are actively displaying, but OHS shall have no obligation to accept such offer.
- g. The Village assumes no responsibility for the safety of any items placed on display or placed in storage and assumes no responsibility for loss, theft, damage or destruction of items left for display. Items on display in a Village building or facility are provided the same security as the Village's collection and equipment. Insurance covering the value of the display will be the responsibility of the OHS.
- h. The OHS acknowledges that no bailment is intended by this Agreement.

30. **Humphrey House.** The Village agrees to continue mowing the lawn of OHS's Humphrey House, located at 9830 W. 144th Place, Orland Park, during the term of this Agreement.

31. **Third Party Beneficiary.** Nothing in this Agreement, whether expressed or implied, is intended to confer any rights or remedies under or by reason of this Agreement on any other person other than the Village and Village, nor is anything in this Agreement intended to relieve or discharge the obligation or liability of any third persons to either the Village or Village, nor shall any provision give any third parties any rights of subrogation or action over or against either the Village or Village. This Agreement is not intended to and does not create any third party beneficiary rights whatsoever.

32. **Limitation of Liability Regarding Governmental Officials.** No covenant or agreement contained in this Agreement shall be deemed to be the covenant or agreement of the corporate authorities, any elected official, officer, partner, member, director, agent, employee or attorney of the Village, in his or her individual capacity and no elected official, officer, partner, member, director, agent, employee or attorney of the Village shall be liable personally under this Agreement or be subject to any personal liability or accountability by reason of or in connection with or arising out of the execution, delivery and performance of this Agreement, or any failure in that connection.
