2019-0441 Budget Kickoff Meeting - FY2020 Budget

Interim Village Manager Thomas Dubelbeis stated tonight's Budget Kickoff Meeting will be a high-level introduction of the 2020 budget process for informational purposes.

Discussion will be on factors from the 2018 and 2019 budgets that are believed to have significant impacts on the FY2020 Budget. The goal is to maintain a twenty percent general fund reserve and implement a revised compensation plan based on preliminary directions from the Board of Trustees. An overview will be provided of the Operating Revenues and Expenses, the Budget Trends through 2019 of April, along with FY2020 Budget Assumptions and input from the Board of Trustees. Finance Director Annmarie Mampe gave a PowerPoint presentation (Exhibit A) and explained each slide. (refer to audio file)

Trustee Dodge arrived at 6:20 P.M.
