



**ADDENDUM E TO BUILDING MECHANICAL SYSTEM PREVENTATIVE
MAINTENANCE AND REPAIRS, DATED JULY 5, 2022, AMENDED SEPTEMBER 16,
2024, DECEMBER 2, 2024, JANUARY 20, 2025, AND SEPTEMBER 15, 2025
BETWEEN
THE VILLAGE OF ORLAND PARK AND MIDWEST MECHANICAL GROUP LLC**

WHEREAS, on July 5, 2022, a certain Agreement between the VILLAGE OF ORLAND PARK (hereinafter referred to as "Village") and Midwest Mechanical Group, LLC (hereinafter referred to as "Consultant") for the performance of certain professional services for the Village in connection with Building Mechanical System Preventative Maintenance and Repairs (hereinafter referred to as the "Project", the "Work", or the "Services") was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, on September 16, 2024, a certain Agreement between the Village and the Consultant for the Project/Work/Services was previously amended (hereinafter referred to as the "Addendum A"); and

WHEREAS, on December 2, 2024, a certain Agreement between the Village and the Consultant for the Project/Work/Services was previously amended (hereinafter referred to as the "Addendum B"); and

WHEREAS, on January 20, 2025, a certain Agreement between the Village and the Consultant for the Project/Work/Services was previously amended (hereinafter referred to as the "Addendum C"); and

WHEREAS, on September 15, 2025, a certain Agreement between the Village and the Consultant for the Project/Work/Services was previously amended (hereinafter referred to as the "Addendum D"); and

WHEREAS, the Village wishes to modify SCOPE OF WORK, COMPENSATION and CONTRACT DOCUMENTS.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum E and the Agreement, the provisions of this Addendum E shall control.
2. **SECTION 1: SCOPE OF THE WORK** of said Agreement shall be amended to include the "Scope of Work" as set forth in Contractor's Invoice #112177496, dated October 22, 2025; Invoice #112178798, dated November 25, 2025; Invoice #112179141, dated December 4, 2025; Invoice #MAST122025, dated December 3, 2025; Invoice #MC0000147550, dated November 4, 2025; Invoice #MC0000147551, dated November 4, 2025; Invoice #MC0000147552, dated November 4, 2025; Invoice #MC0000147553,

dated November 4, 2025; Invoice #MC0000147554, dated November 4, 2025; Invoice #MC0000147555, dated November 4, 2025; and Invoice #MC0000147557, dated November 4, 2025.

3. **SECTION 2A: COMPENSATION** in said Agreement shall be amended to strike the words “a total not-to-exceed contract price of \$191,230.76 for 2025” and replace with “a total not-to-exceed contract price of \$234,503.60 for 2025” to increase contract amount by an additional \$43,272.84 for FY 2025.
4. **SECTION 3: THE CONTRACT DOCUMENTS** of said Agreement shall be amended to include Addendum E dated January 19, 2026.
5. **SECTION 4A: TERM OF THE CONTRACT** of said Agreement shall remain December 31, 2026, per Addendum B.
6. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
7. This Addendum E may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum E, made and entered into effective the **19th day of January, 2026**, shall be attached to and form a part of the Agreement dated the 5th day of July, 2022, amended September 16, 2024; December 2, 2024; January 15, 2025, and September 15, 2025, and shall take effect upon signature below by duly authorized agents of both parties.
