ADDENDUM A TO RECH ENTERTAINMENT COMPANY LLC PROFESSIOINAL ARTIST SERVICES DATED FEBRUARY 17, 2025 BETWEEN

THE VILLAGE OF ORLAND PARK AND RECH ENTERTAINMENT COMPANY, LLC

WHEREAS, February 17, 2026, a certain Agreement between the VILLAGE OF ORLAND PARK (hereinafter referred to as "Village") and Rech Entertainment Company, LLC (hereinafter referred to as "Consultant") for the performance of certain professional services for the Village in connection with talent buying, contract and rider negotiation, advancing artist production requirements including transportation, backline, hospitality, hotel and other specifications outlined in artist's riders for the Centennial Park West Concert Series and Taste of Orland Park. (hereinafter referred to as the "Project", the "Work", or the "Services") was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, the Village wishes to modify SCOPE OF WORK, COMPENSATION and CONTRACT DOCUMENTS.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

- 1. In the event of any conflict or inconsistency between the provisions of this Addendum A and the Agreement, the provisions of this Addendum A shall control.
 - SECTION 1: SCOPE OF THE WORK of said Agreement shall be amended to include the "Scope of Work" as set forth in Consultant's Proposal, dated June 10, 2025 due to the total cost for talent buying, contract and rider negotiation, advancing artist production requirements including transportation, backline, hospitality, hotel and other specifications outlined in artist's riders for the Centennial Park West Concert Series and Taste of Orland Park exceeding the previously projected amount.
- SECTION 2A: COMPENSATION in said Agreement shall be amended to strike the not-to-exceed amount of \$53,500.00 for FY 2025; and replace with a new "not-to-exceed amount of \$59,000.00 for FY 2025. The contract increased by \$5,500.
- 3. SECTION 3: THE CONTRACT DOCUMENTS of said Agreement shall be amended to include Addendum A, dated July 28, 2025, for the amended "Proposal for Work", dated June 10, 2025.
- All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
- 5. This Addendum A may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum A, made and entered into effective the 28th day of July 2025, shall be attached to and form a part of the Agreement dated the 17th of February 2025, and shall take effect upon signature below by duly authorized agents of both parties.
