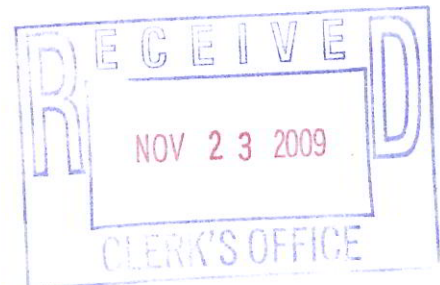

Statement of Work (SOW)

This Statement of Work will be incorporated into the Contract for Technical Consulting Services dated August 18, 2008 and that certain Services Agreement with an Effective Date of May 17th, 2006 between SWC Technology Partners Inc. ("SWC") and Village of Orland Park ("VOP").

All terms and conditions of the Services Agreement not modified herein remain in full force and effect for the Term of the Agreement.

1. Objective and Scope of Project

The scope of this project is to migrate the existing Symantec Gateway Security ("SGS") firewall appliance to a Cisco ASA 5510 ("ASA") firewall cluster for high availability at the Village office located in Orland Park. Testing of application functionality after the changes have been implemented will be performed by VOP Staff.

2. Scope of Services

Changes to be implemented are as follows:

- a. Firewall migration process planning.
- b. Coordinate required DNS changes for VOP domains.
- c. Perform initial firewall configuration based on existing SGS configuration.
- d. Migrate 41 existing access rules, 15 IP Translations from SGS to ASA.
- e. Implement SSL VPN tunnel for remote access by VOP staff, configure 3 VPN users, and provide knowledge transfer to VOP staff for creation of additional users.
- f. Install and configure Cisco Advanced Intrusion Prevention service module.

SWC will perform the above firewall migration on a time and materials basis during normal business hours.

3. Pricing

The table below summarizes our pricing for the services outlined in this SOW.



4. Billing and Payment


- Hours will be billed on a time and materials basis with invoices being generated monthly.
