This letter is to inform you that the Suburban Purchasing Cooperative's Governing Board has approved the third of three possible one year contract extension of the SPC Natural Deicing Liquid Contract #119 to Road Solutions, Inc., Indianapolis, IN. The duration of the contract extension is November 9, 2014 through November 8, 2015. The Governing Board has also agreed to the following price increases:




