ORDINANCE AUTHORIZING DONATION OF PERSONAL PROPERTY (CLOTHING AND PERSONAL EFFECTS) OWNED BY THE VILLAGE OF ORLAND PARK, ILLINOIS

...B

WHEREAS, the Village of Orland Park is the owner of personal property (clothing and personal effects) described on EXHIBIT A attached hereto and incorporated herein by reference that is of no use to the Village; and

WHEREAS, the Corporate Authorities of the Village of Orland Park, Cook and Will Counties, Illinois, have decided that it is no longer necessary or useful for the Village of Orland Park to retain ownership of the personal property described on EXHIBIT A; and

WHEREAS, the Corporate Authorities have, therefore, decided that continued ownership of the said personal property described on EXHIBIT A is not in the best interests of the Village of Orland Park; and

WHEREAS, the Crisis Center for South Suburbia, which is located in Tinley Park, Illinois, is a charitable organization that provides aid to south suburban families encountering severe need and which organization has immediate need for the said personal property.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Orland Park, Illinois, as follows:

SECTION 1

The above recitals are hereby incorporated into this section as fully as if they were set forth herein in their entirety.

SECTION 2

Pursuant to Section 11-76-4 of the Illinois Municipal Code, Illinois Compiled Statutes, 65 ILCS 5/11-76-4, the President and the Board of Trustees of the Village of Orland Park find that the items of personal property listed on EXHIBIT A now owned by the Village of Orland Park, Illinois, are no longer necessary or useful to the said Village and its best interests will be served by the donation of such personal property by the Village Manager.

SECTION 3

Pursuant to the said Section 11-76-4, the Village Manager is hereby authorized to and may direct the donation of the personal property to which Section 2 of this Ordinance refers by donating said personal property to the Crisis Center of South Suburbia free of charge.

SECTION 4

This Ordinance shall be in full force and effect from and after its passage, by a vote of at least a simple majority of the Corporate Authorities, and approval in the manner provided by law.
