2024-0835 Zoning Map Amendment - 11300 151st Street - Lorenz Residence

Associate Planner Andrew Gardiner respectfully requested the staff report be accepted into the record as written and presented during the meeting. (refer to staff report)

Mr. Gardiner stated the petitioner submitted a petition to rezone his 1.2-acre property in the Orland Grove Planning District from E-1 Estate Residential to R-3 Residential. It already meets the requirements for R-3 zoning. (refer to audio)

The subject property is designated R3 in the Comprehensive Plan and meets all the requirements of the R-3 Residential District.

Mr. Gardiner stated the staff recommends the Plan Commission approve a zoning map amendment for 11300 151st Street from E-1 Estate Residential to R-3 Residential District.

Chairman Parisi asked Mr. Gardiner if he had accepted the petitioner's replies to the LaSalle Factors.

Mr. Gardiner responded, that's correct.

Village Attorney Anne Skrodzki swore in Petitioner John Lorenz.

Mr. Lorenz stated my wife, and I are both local, she's from Orland Park and I'm from Frankfort. We have three boys under the age of four and are looking to do an addition to our home. The zoning will give us an extra 10 feet for that addition, and it will accommodate it. We're hoping with your permission to go forward with that.

2024-0952 Text Amendment - Section 6-307. Signs

Andrew Gardiner respectfully requested the staff report be accepted into the record as written and presented during the meeting. (refer to staff report)

Mr. Gardiner stated we're looking to accomplish two things with this sign code amendment. We'd like to clarify the Village's standards for multi-tenant ground signs, and we'd also like to allow halo-lit signage. We'd like to define a halo-lit sign as a type of sign where an internal light source illuminates the wall or mounting surface behind the sign creating a glowing effect, 1.5" from the back of sign to the mounted surface. A wall sign can be front face illuminated or halo-lit, but not both. The halo-lit light may only be white in color. Panels on multi-tenant ground signs must have a uniform background and text color. Fonts may vary by tenant and logos are exempt from the color requirements.

Mr. Gardiner stated the staff recommends the Plan Commission approve the Land

Development Code Amendment for Section 6-307 as presented in the attached amendment report titled "Staff Report LDC S6-307 Sign Amendment(s)" dated December 13, 2024.

Commissioner Zaatar, no questions.

Commissioner Sanchez, no questions.

Commissioner Paul asked why are we restricting it to one color?

Mr. Gardiner stated, simplicity and legibility. If you have signs that are illuminated different colors, particularly blues or purples, it can be very difficult to read from the right-of-way.

Commissioner Paul stated from our perspective, why would we care? I can see from a company's side, if it's my business and I'm putting a sign up obviously I want it to be seen, but from a regulatory side, why would we be concerned about that?

Mr. Gardiner replied I'd have a concern for public safety. If someone's having difficulty reading signage, especially while they're driving, I don't want them to have to spend too long trying to distinguish a sign.

Commissioner Paul responded, that makes sense. I appreciate that. That's all I have.

Commissioner Zomparelli asked if the two examples that were shown were illuminated halo lights and if there's no lighting, just a projection?

Mr. Gardiner responded the LEDs are mounted on the back of the signage and face towards the building.

Commissioner Zomparelli replied pretty cool. I never realized that I'm learning something. Other towns do this right?

Mr. Gardiner stated both of those signs are from businesses in Orland Park currently.

Commissioner Zomparelli responded that's really it, seems pretty simple, thank you.

Commissioner Nugent asked about the mall redo where Pediatric Dentistry is and if their sign has reflective lighting in the back? Are you familiar with it?

Mr. Gardiner responded not too familiar.

Commissioner Nugent asked we don't currently allow some kind of lighting behind signs now? This is different.

Mr. Gardiner replied this is different, yes. There have been signs, but they have not been allowed.

Commissioner Nugent added their signs seem illuminated, so the sign is just lit where this is a halo in the back, right?

Mr. Gardiner responded it's also quite possible that they have a halo-lit sign illegally currently. We have a lot.

Commissioner Nugent referred to the illuminated lights in Palos Hills and Worth along Harlem Avenue looking like Vegas at night and asked if our lights will be on the structure and not at the street? (refer to audio)

Mr. Gardiner responded, yes. The definition explicitly does not allow for any of the light source to be visible from the public right-of-way.

Commissioner Nugent asked if what Wild Fork is doing, just a lit sign, that's allowed? It's attractive. It's not obnoxious. It's all at the building?

Mr. Gardiner responded, yes.

Commissioner Schussler stated that the staff summary, third paragraph, indicates, "the goal of this amendment is to provide more flexibility in our commercial areas by allowing this popular new and modern sign design while maintaining the high standards of the Village and minimizing adverse impacts on the surrounding area." I agree with this 100 percent, but I would say if we really want to allow more flexibility to what's popular, new, and modern, and maintain our high standards, we should also allow digital signs because they're all over the place even more so than these halo-lilt signs. (refer to audio)

Chairman Parisi stated wasn't the issue with the digital signs that there was a distraction to traffic. I think the Board has an issue with it.

Commissioner Schussler responded I think the Board has an issue with it. I'm only bringing this up to indicate that the Board on that issue is not current with the times. You can have digital signs that are gaudy, too bright, a real hazard where they're so bright that they're distracting. They can be flashing so they could be real safety hazards, but you could have digital signs with regulation, similar to the regulations you're proposing for the halo signs. You can say that you won't allow them to be banding where they're constantly sending some message around, that there's a certain limitation on the nits. You can restrict the number of times the sign

can change within a certain time parameter. You can do all kinds of things to make them more practical. I'm suggesting that in Orland Park we also allow digital signs that are regulated. (refer to audio)

Chairman Parisi stated, that's a good observation. Thank you. I have nothing to add.

Commissioner Schussler responded they've asked for it, trust me, I was on the Board when it was asked.

Commissioner Zaatar stated now we're allowing this new petitioner and maybe the old people who wanted to do something fancy with their sign they should be aware the sign code was updated so now they can do whatever they want to do. There're probably people just a year or two ago who paid lots of money for signs and didn't get the one they wanted. Maybe we need to update all the lines on the sign code and not just one line because of one petitioner.

Chairman Parisi stated that's what I was thinking. I've been here when we denied these digital signs.

Commissioner Zaatar added he's right, like now the digital signs are in some towns and are doing them nicely.

Commissioner Nugent stated you can use it as a perfect study example. If people want to figure it out, start their drive around the soccer stadium at 71st and Harlem and drive from there and you'll see the whole spectrum. (refer to audio)
