## ..Title

V3 Companies - Pond Stewardship and Management Task Order 2.0 - Proposal History

Over the years, since the Village accepted the plethora of ponds and detention areas that comprise the stormwater management system for the Village, there have been varying levels of stormwater basin maintenance and management performed by differing Departments and contractors. Included in these efforts have been shoreline plantings, re-plantings and aquatic vegetation improvements.

In an effort to develop a sustainable maintenance and management plan for the over 400 ponds that comprise the Village's stormwater management and pond system, Public Works has been working with Parks and Administration over the past years.

For the 2011 budget, in response to neighborhood and Village concerns regarding the condition and appearance of many of the Village's ponds, Public Works requested that funds be included in the Capital Fund Budget to begin to comprehensively address a growing number of pond-related issues. Following the Board's concurrence that ponds within the Village are a concern, Staff reviewed services and proposals from several current vendors ultimately asking V3 Companies, based upon their expertise, experience and past successful performance here and elsewhere, to provide a scope and fee proposal for two demonstration projects: The Village Hall Complex South Basin, and the Imperial West (Breckinridge) Ponds. During the process of developing a scope and fee proposal, V3's professional engineering evaluation determined that the Imperial West Pond requires a review of the as-built pond plans, along with nominal field work to determine the viability of the pond. A nominal work order (Task Order 2.2) at a cost of less that \$2,500 has been approved for work associated with the Imperial West Pond.

Staff has reviewed the multi-year proposal from V3 for Pond Stewardship and Management and finds the proposal to be of very good value. Their proposal and a more comprehensive narrative for work associated with this Item are included as Attachments.
