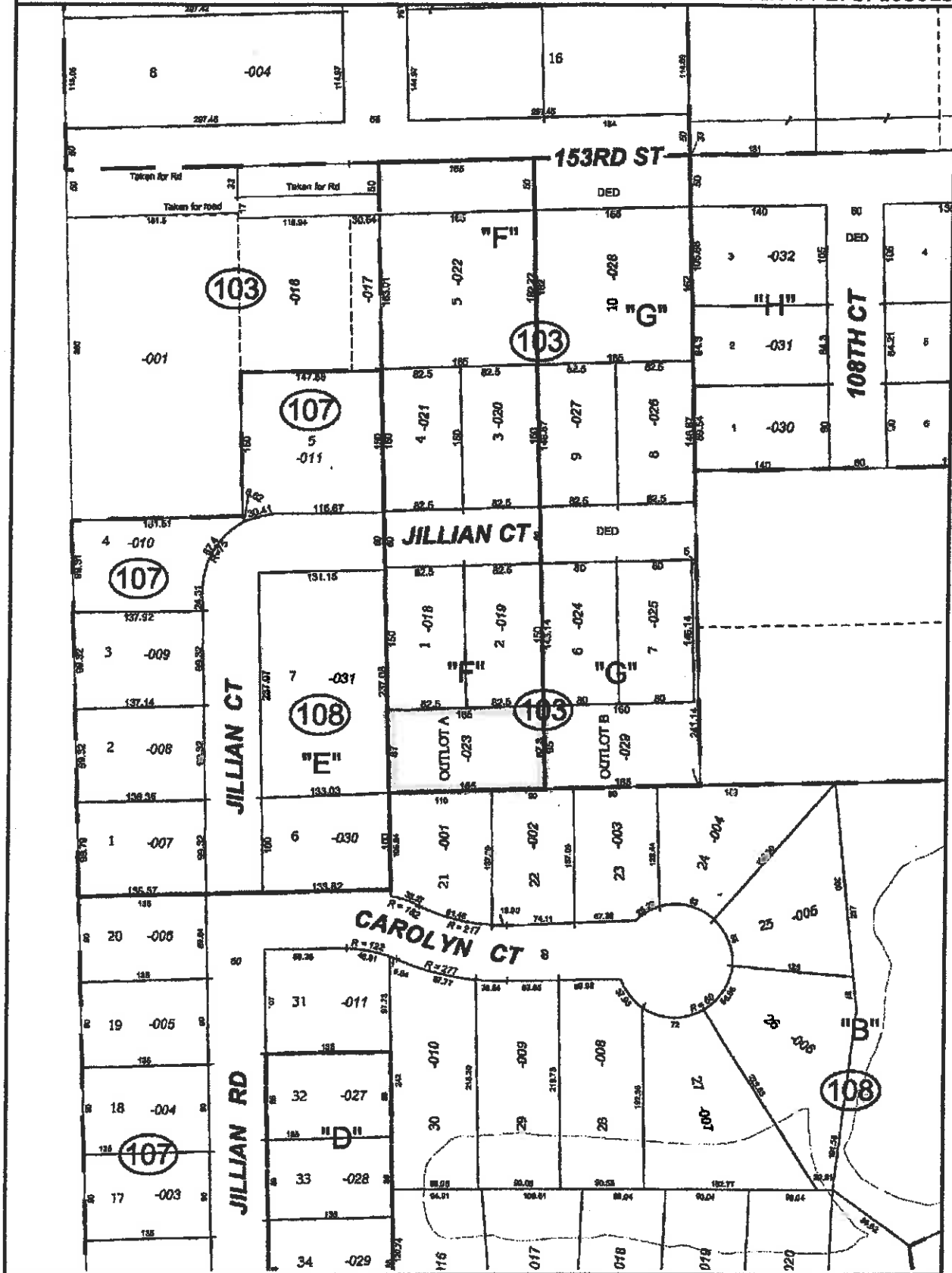

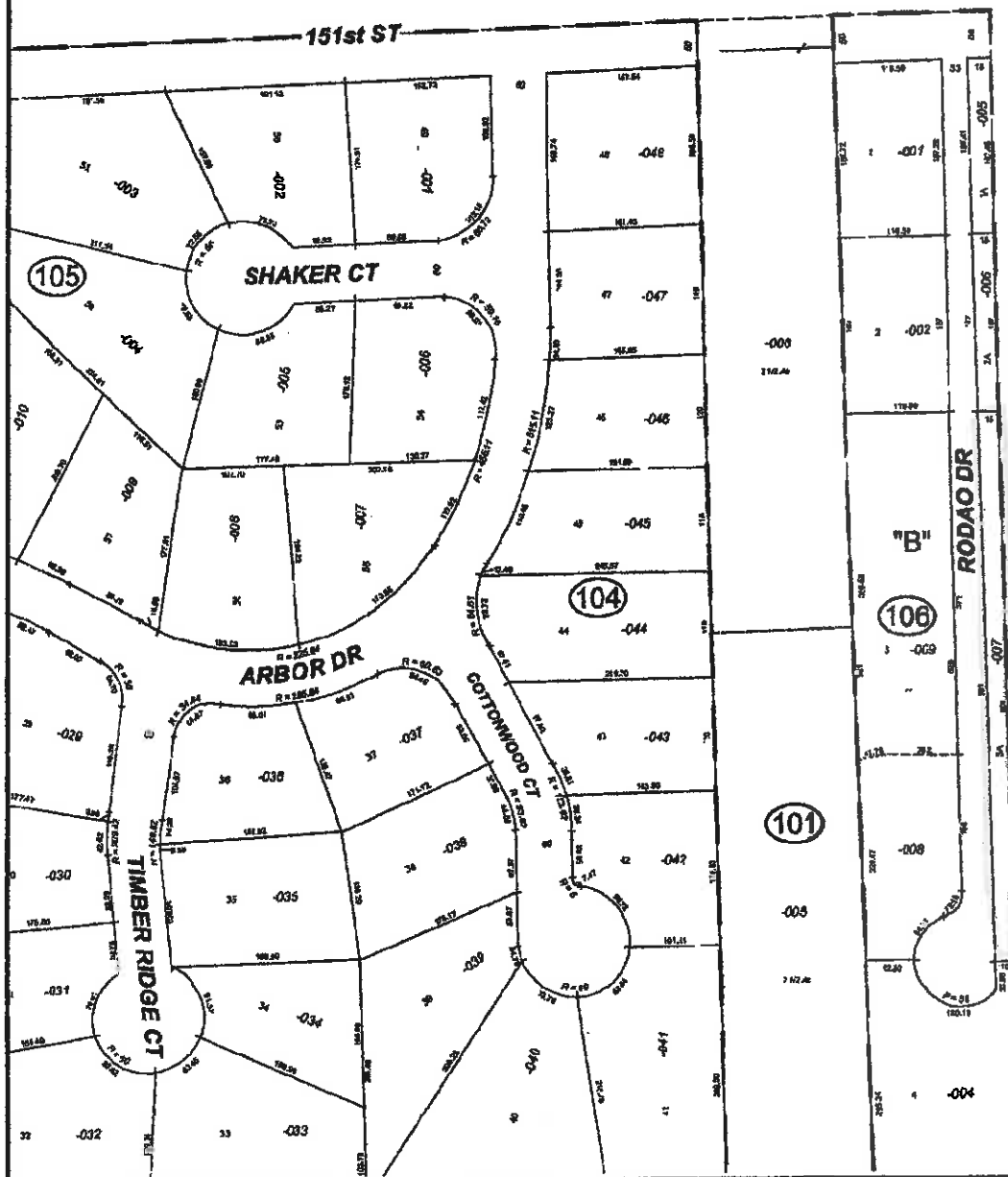
LOT 3A IN CANTERBURY COURT, A SUBDIVISION OF PART OF THE NORTHEAST

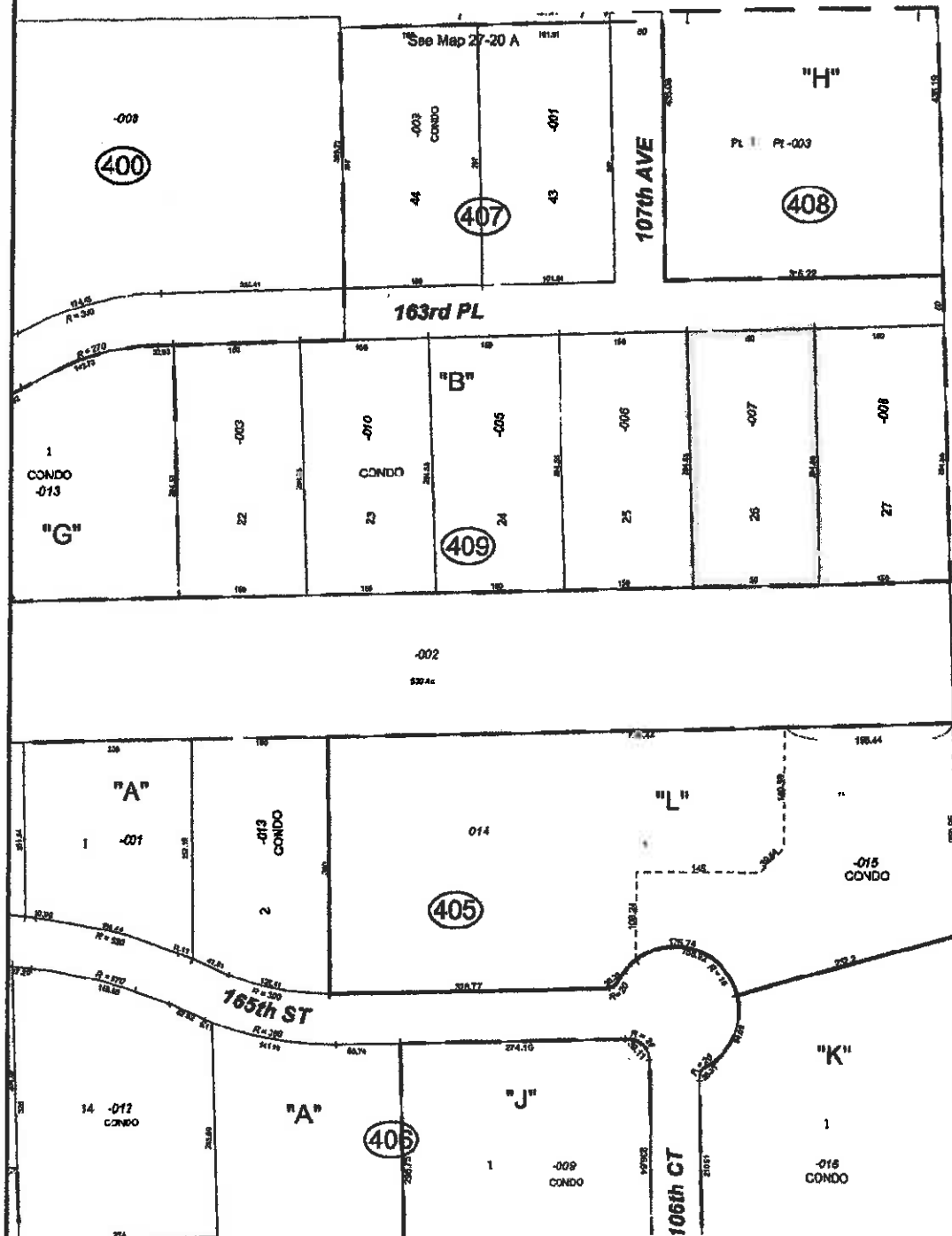

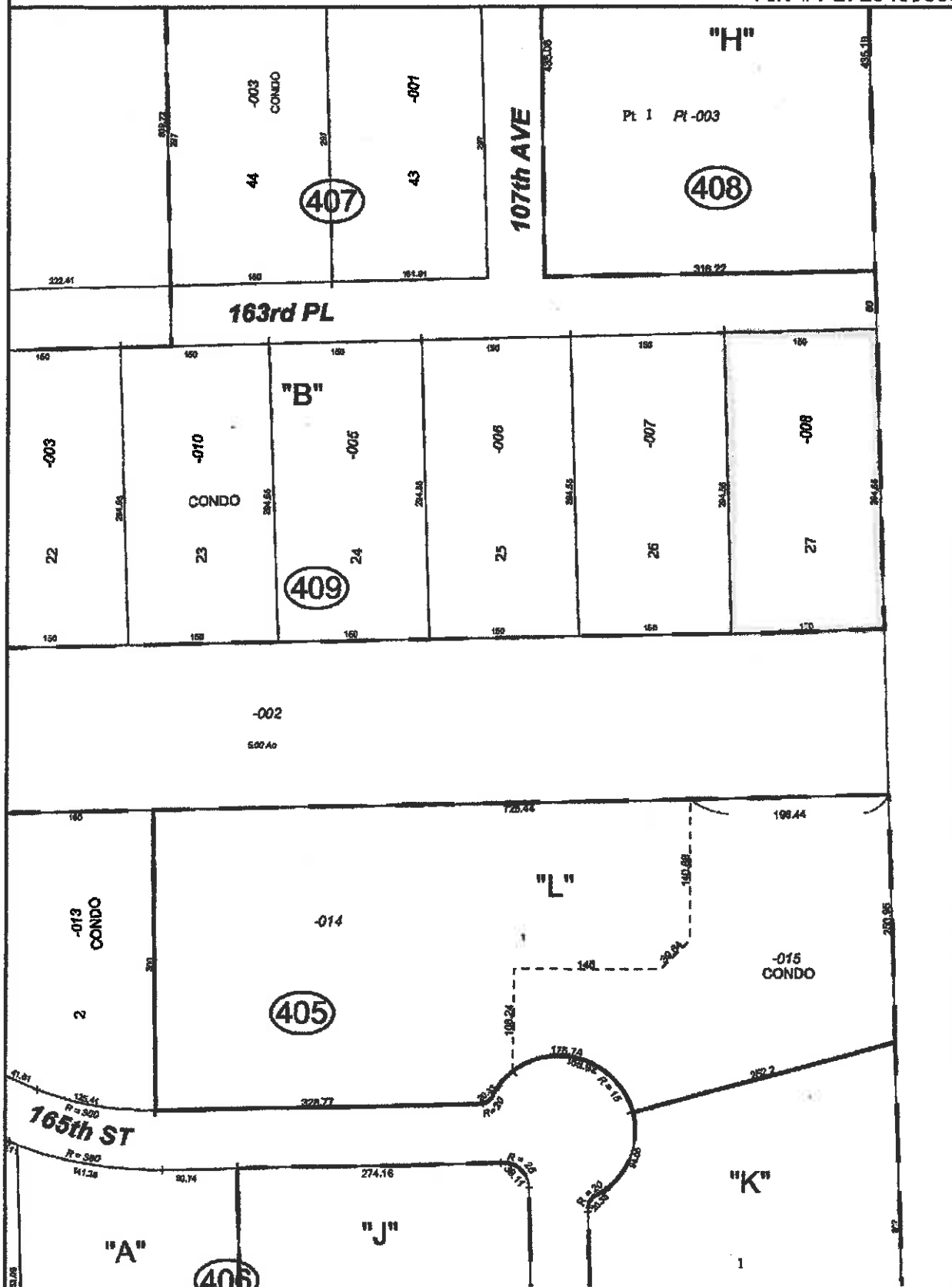

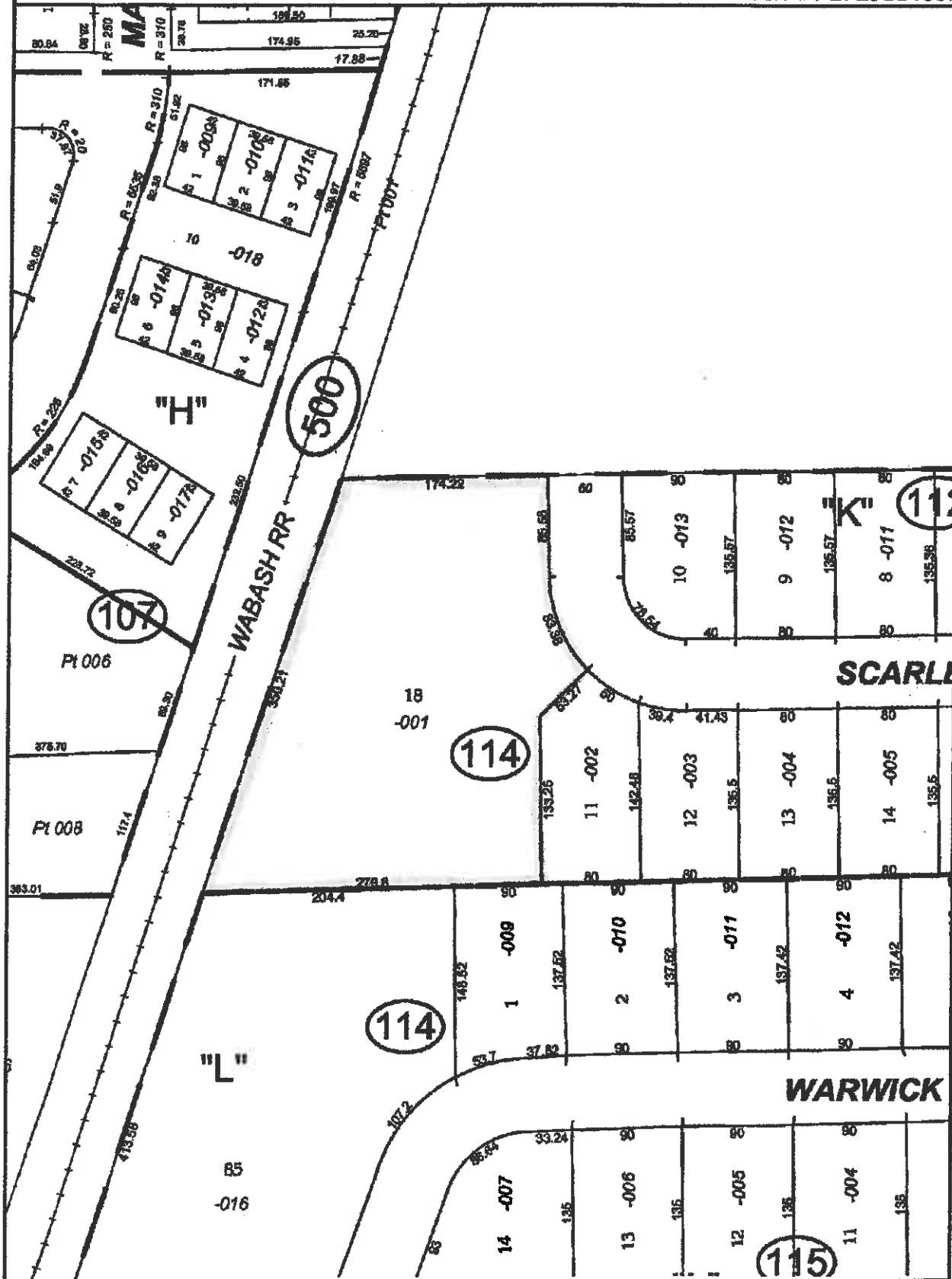
