7. CONDITIONS OF PERFORMANCE:
 - a. Agreement of the Artist to perform is subject to proven sickness, accidents, riots strikes, acts of God or any other legitimate conditions beyond their control. In such an event, ARTIST is not liable for any consequential damages. Purchaser's sole remedy shall be a refund of any deposit paid by the PURCHASER.
 - b. Purchaser agrees to provide Public Liability Insurance coverage to protect against injuries to person(s) and/or property in any way resulting from said engagement which is the subject of this contract. Purchaser shall further agree to indemnify and hold ARTIST, their contractors, employees, licensee, and designees harmless from and against any fees, incurred or suffered by ARTIST as a result of any claim for personal injury or property damage brought by or on behalf of any third party. This clause is not designed to encompass any action by ARTIST which is willful and/or intentional.
 - c. Purchaser agrees to take whatever actions necessary to provide security measures to protect ARTIST from injury and damages to person(s) and/or property. Purchaser further agrees to secure its premises against loss or damage to ARTIST's property while said property remains at PURCHASER'S place of business.
 - d. ARTIST shall not perform in unsafe conditions. Specifically outdoor performances in rainy or other wet conditions which may result in electrical shock. Full contract balance shall become due immediately should weather cause a cancellation of the performance.
 - e. Unless otherwise indicated, PURCHASER shall provide ARTIST with a adequate stage as well as electrical requirements necessary to perform the show.
8. AGENCY PROVISIONS:
 - a. The ARTIST executes this agreement as an independent contractor. The ARTIST assumes sole responsibility for appropriate payment of federal, state and local taxes for ARTIST income resulting from the engagement.
 - b. Double D Booking shall not be held liable for the default of the PURCHASER nor the non-performance of the ARTIST. Double D Booking shall not be liable for any actions by the purchaser or ARTIST which result in injuries or damages to person(s) and/or property which in any way results from said engagement which is the subject of this contract. PURCHASER and ARTIST agree to indemnify and hold Double D Booking harmless from any claims or causes of action which may result from the performance which is the subject of this contract.
 - c. Any controversy or claim arising of or relating to this contract or breach thereof, shall be litigated in the Cook County Courts and under the laws of the state of Illinois. ~~PURCHASER agrees to be responsible for all costs of collection including attorney fees along with 12% interest of the unpaid balance.~~
 - d. Members of unions or guilds, which may include the leader or members of this unit, agree to accept sole responsibility for complying with the rules and regulations of their membership.
9. This contract is not altered by the oral agreement or oral representations of party hereto although PURCHASER's oral reservation of the aforementioned date binds PURCHASER to contract. This written contract is a written memoranda of the oral agreement which the PURCHASER and ARTIST/ ARTIST's AGENT have previously entered.
