
Dear Mr. Schumal:

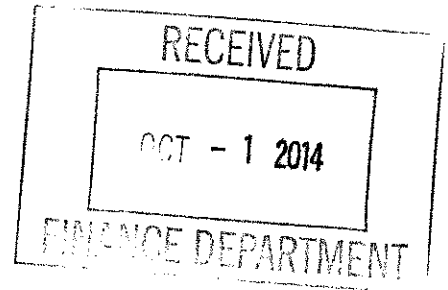

2014 Road Improvement Agreement

**Dated**  
May 9, 2014

**Amended**  
August 21, 2014



**Between**  
The Village of Orland Park, Illinois ("VILLAGE") and Austin Tyler Construction Inc.  
("CONTRACTOR")

1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2. In **SECTION 1: THE CONTRACT DOCUMENTS**, of said Agreement, "Addendum B Asphalt Restoration" shall be added after "Addendum A Sidewalk Gap/Path Construction".
3. In **SECTION 2: SCOPE OF THE WORK AND PAYMENT**, of said Agreement, the words "Addendum B Asphalt Restoration \$ 12,639.12" shall be added after "Addendum A Sidewalk Gap/Path Construction \$ 50,000"; and  
  
the words "TOTAL: an amount not to exceed Two Million Six Hundred Fifty-Seven Thousand and No/100 (\$2,657,000.00) Dollars." shall be stricken their entirety and replaced with "TOTAL: an amount not to exceed Two Million Six Hundred Sixty Nine Thousand Six Hundred Thirty-Nine and 12/100 (\$2,669,639.12) Dollars."
4. All of the other terms, covenants, representations and conditions of said Agreement, not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
5. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum, made and entered into effective the **29th day of September, 2014**, shall be attached to and form a part of the Agreement dated the 9<sup>th</sup> day of May, 2014 and shall take effect upon signature below by duly authorized agents of both parties.


