WHEREAS, on January 13, 2021, a certain Agreement regarding Centennial Park Aquatic Center (CPAC) VGBA Grating Improvements between the Village and the Contractor was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, on May 12, 2021, a certain Agreement regarding Centennial Park Aquatic Center (CPAC) VGBA Grating Improvements between the Village and the Contractor was amended (hereinafter referred to as the "Addendum A"); and

WHEREAS, the Village wishes to modify TERM OF THE CONTRACT.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2. **SECTION 4: TERM OF THE CONTRACT** of said Agreement shall be amended to include strike the words "May 1, 2021," and replace with "October 1, 2021."
3. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
4. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum, made and entered into effective the **12 day of May, 2021**, shall be attached to and form a part of the Agreement dated the 13 day of January, 2021, and shall take effect upon signature below by duly authorized agents of both parties.
