WE ARE PLEASED TO PROVIDE A PROPOSAL FOR THE ABOVE MENTIONED PROJECT, AND OUR COST FOR THE ELECTRICAL WORK IS AS FOLLOWS: **\$82,450.00**

THE FOLLOWING PERTAINS TO OUR PROPOSAL:

1. Remove existing (2) pairs of doors and frames on south entrance.
2. Furnish and install (2) pairs of Oldcastle colonial white doors and frames on the south elevation. Door frame will be 4" x 2" except at head which will be 4" x 6" to hold auto op.
3. Doors to have 10" stainless offset D pull handles, full size gear hinges and von duprin panics to match other doors. 18" stacked bottom rail 3 ½" head and 3 ¾" sides. Threshold for exterior entrance.
4. Doors to be glazed with 1" grey tempered insulated units.
5. Furnish and install approximately 100' of conduit and wire to existing electrical panel.
6. Furnish and install (1) 20A 120V circuit for door operators.
7. Furnish and install (2) dual door push auto operators required.
8. Furnish and install (4) activation paddle switches.
9. Furnish and install (1) stainless paddle switch stand.
10. Repair drywall ceiling and walls patch, prime and paint in vestibule area.
11. All work performed during normal working hours.
12. Work due to concealed conditions not included.
