SCOPE OF WORK: CAREFREE WILL INSTALL IRRIGATION AT THE LOCATION ABOVE. IRRIGATION WILL BE INSTALLED PER LANDSCAPE PLAN AND IRRIGATION LIMITS.

SCOPE OF WORK WILL INCLUDE. CAREFREE TO PROVIDE IRRIGATION IN AS AN ALTERNATE TO ORIGINAL SCOPE

ALTERNATE 1: CAREFREE TO PROVIDE IRRIGATION TO NORTH LAWN AREA, TRIANGLE TURF AREA NORTH WEST OF LAWN SEATING, WEST OF STAGE. CAREFREE TO PROVIDE IRRIGATION PVC MAINLINE, DIRECTIONAL BORE, SPRAY TYPE HEADS, AND COMMERCIAL ROTOR TYPE HEADS. CAREFREE TO PROVIDE ADDITIONAL IRRIGATION CONTROLLER TO BE MOUNTED ON NORTH FIELD. ELECTRIC OUTLET BY OTHERS. CONTROLLER TO BE LOCKABLE AND RAIN SENSOR TO BE MOUNTED ON POLE. CAREFREE TO PROVIDE A FLOW SWITCH THAT WILL ACTIVATE BOOSTER PUMP WHEN CONTROLLER RUNS CYCLE.

The base system shall consist of the following components:

RAIN BIRD FALCON ROTORS
RAIN BIRD 5004 ROTOR
IRRITROL 700 VALVES IN BOXES
3" PVC MAINLINE
2" PVCE MAINLINE
1.5" 80 PSI LATERAL PIPE
1813 FIELD CONTROL WIRE
DIRECTIONAL BORE/AUGER

All fittings, piping, wiring, etc. necessary to perform the installation in a professional manner. The actual head & techline quantities will be determined at the time of installation based on the final landscape plan with the objective of delivering coverage to the grass and landscaped areas. All components of the system are covered by a one year manufacturer's warranty. Carefree will provide the labor for the replacement of any defective components for a period of one year from the date of completion. This proposal includes the fall winterization and is based on working water pressure of 60 psi. and a flow rate of 40 gpm.
