



ADDENDUM A TO BODY & FLEET CAMERAS/TASER 10/SOFTWARE MASTER SERVICE AGREEMENT, DATED DECEMBER 19, 2024, BETWEEN THE VILLAGE OF ORLAND PARK AND AXON ENTERPRISE, INC.

WHEREAS, on December 19, 2024, a certain Agreement between the VILLAGE OF ORLAND PARK (hereinafter referred to as "Village") and Axon Enterprise, Inc. (hereinafter referred to as "Consultant") for the performance of certain professional services for the Village in connection with Body & Fleet Cameras/Taser 10/Software (hereinafter referred to as the "Project", the "Work", or the "Services") was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, the Village wishes to modify **SCOPE OF THE WORK, COMPENSATION, AND THE CONTRACT DOCUMENTS**:


1. In the event of any conflict or inconsistency between the provisions of this Addendum A and the Agreement, the provisions of this Addendum A shall control.
2. **SCOPE OF THE WORK** of said Agreement shall be amended to include the "Scope of Work" as set forth in Consultant's Proposal Q-735676-46038DA, dated January 16, 2026, to purchase eight (8) additional body-worn cameras and seventeen (17) associated software licenses.
3. **COMPENSATION** in said Agreement shall be amended to strike "Not-to-exceed amount of \$1,500,000.00" and replace with a new "Not-to-exceed amount of \$1,674,449.49". Contract was increased by \$174,449.49.
4. **THE CONTRACT DOCUMENTS** of said Agreement shall be amended to include Addendum A, dated February 11, 2026: and "Consultant's Proposal, Q-735676-46038DA, dated January 16, 2026".
5. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
6. This Addendum A may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum A, made and entered into effective the **11th day of February 2026**, shall be attached to and form a part of the Agreement dated the 19th day of December 2024, and shall take effect upon signature below by duly authorized agents of both parties.
