2018-0754 Amending Title 9, Chapter 7 of the Village Code to Prohibit Parking and Allowing the Towing of Vehicles on Certain Streets to Facilitate Garbage Collection - Ordinance

Garbage pickup has been hampered on Franklin Court, Lunar Court, Lincoln Court, Kennedy Court and Orland Court due to parked vehicles parking near drive way entrances to the parking lots. The garbage trucks are unable to make the proper turns to pick up the garbage located behind the buildings. The width of these streets is only 24 ft. versus our standard 27 ft. which reduces the turn radius for the trucks.

The property owners attempted to assist the village by informing the tenants and requesting they voluntary compliance with no success. The failure to pick up the garbage in a timely manner has created an over flow of garbage that spills out of the containers creating a public health risk.

To correct this issue, we are proposing a no parking/tow zone restriction at the following locations from times between 0700 - 1000 on Thursdays and the days after a recognized holiday to insure that the garbage is picked up regularly:

The north side of Lunar Court and Kennedy Court. The south side of Franklin Court, Lincoln Court and Orland Court.

2018-0724 FY2019 Liability/Property Insurance Renewal - Approval

The Horton Group has provided the Village with its renewal premium amounts for Fiscal Year 2019 for all property and liability insurance policies, including Excess Workers Compensation.

Overall, the Village's FY2019 liability and property premiums, including Horton's annual service fee and CCMSI's claims handling fee, decreased \$21,061 or approximately 2.6%, as compared to FY2018 amounts. Decreases to property/auto physical damage and network security/privacy liability premiums were offset by slight increases in the public entity package, drone and worker's compensation premiums. The decrease in the property/auto physical damage premium is due to our long history with the carrier, excellent loss history, and current market conditions. The decrease in the network security/privacy premium is due to our long history with this coverage as well as a change in carriers.

CCMSI's claims handling fee is assumed to remain the same for the 2019-2020 policy term. The Horton Group's annual service fee decreased by \$5,000. Retention amounts (deductibles) on each of the lines remained the same, with the exception of the network security/privacy retention which decreased from \$25,000 to \$15,000.

Staff recommends that the Village continue to utilize the services of The Horton Group for Fiscal Year 2019.

DEVELOPMENT SERVICES, PLANNING AND ENGINEERING

2015-0381 St. Coletta's of Illinois Residential Care Home

The petitioner is requesting a special use permit to establish a medium residential care home for six (6) residents in a single-family detached house located at 14401 Oakley Avenue.

St. Coletta's of Illinois (St. Coletta's) is a non-profit organization established in 1949. The organization's main campus is located at 18350 Crossing Drive in Tinley Park. According to the petitioner, St. Coletta's operates an extensive Community Integrated Living Arrangement (CILA) Residential Program in the southwest suburban area, and currently operates twenty-five (25) adult residential care homes spread out in sixteen different municipalities, twenty of which are operated with six (6) residents.

St. Coletta's currently operates two (2) residential care homes in Orland Park. One of these homes is located in the R-3 Residential District and has six (6) residents, but was established prior to the Land Development Code (LDC) requirements for care homes and as such does not require a special use permit. The other residential care home is located in the R-3 Residential District and houses only five (5) residents, and is thus considered a permitted use.

The petitioner has also requested a variance to the Village Building Code through the Building Department to accommodate the special needs of this project. This variance (2015-0569) was approved by the Board of Trustees on October 5, 2015.

The petitioner is requesting a special use permit to establish a residential care home in a single-family detached house located at 14401 Oakley Avenue, in the Oak Meadows subdivision. The proposed residential care home would be occupied by six (6) adult male residents with 24-hour supervision from a St. Coletta's staff member. The six (6) adult occupants would be ambulatory, developmentally disabled males ranging in age from 21 to 47 years old who have a primary diagnosis of mental retardation. All of the residents would attend a vocational day programming Monday through Friday from 8:30 a.m. to 3:30 p.m.

The proposed location for the residential care home is located in the R-3 Residential Zoning District. LDC Section 6-204.C.7 states that medium residential care homes (defined as 6 - 8 residents) are permitted as a special use in the R-3 zoning district provided that the petitioner is licensed by the applicable State agency and the home is located no closer than 660 feet to any other residential care home or congregate elderly housing facility.

St. Coletta's of Illinois is licensed by the State of Illinois as a Community Integrated Living Arrangement (CILA) provider, which is the terminology used to describe residential care homes by the Illinois Department of Human Services. To the best of the Village's knowledge, no other residential care home or congregate elderly housing facility is located within 660 feet of the proposed location.

The motion includes the following conditions:

1) Meet all final engineering and building code related items.

Overall, the project conforms to the Village's Comprehensive Plan, Land Development Codes and policies for this area.

The Public Safety Employee Benefits Act PSEBA (820 ILCS 320/) Requires that "an employer who employs a full-time law enforcement, correctional or correctional probation officer, or firefighter, who, on or after the effective date of this Act suffers a catastrophic injury or is killed in the line of duty shall pay the entire premium of the employer's health insurance plan for the injured employee, the injured employee's spouse, and for each dependent child of the injured employee until the child reaches the age of majority or until the end of the calendar year in which the child reaches the age of 25 if the child continues to be dependent for support or the child is a full-time or part-time student and is dependent for support."

The attached ordinance in Legistar setting forth a formal procedure for applying for and determining PSEBA claims is recommended by legal and is based on a model ordinance drafted by the Illinois Municipal League (IML). Most importantly, the ordinance defines "catastrophic injury", "gainful work" and "injury" which the state statute mandating the PSEBA benefits does not.
