Between

The Village of Orland Park, Illinois ("VILLAGE") and Crowley-Sheppard Asphalt Inc. ("CONTRACTOR")

WHEREAS, on September 9, 2015, a certain Agreement regarding Fountain Village Development Completion between the Village and the Contractor was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, the Village wishes to increase the SCOPE OF WORK.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2. **SECTION 2: SCOPE OF THE WORK AND PAYMENT** of said Agreement shall be amended to include the following:

"Completion of approximately 350 feet of bike path in the adjacent Parkview Plaza subdivision (see attached drawings) for an amount not to exceed Ten Thousand and No/100 (\$10,000.00 Dollars")
3. **SECTION 4: TERM OF THE CONTRACT** of said Agreement shall be amended to include the following:
4. All of the other terms, covenants, representations and conditions of said Agreement and Addendum dated month, day, 20xx, not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
5. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.
