## PERFORMANCE AGREEMENT

This agreement, entered into as of this 9th day of October, 2012, between Emergence Dance Theatre, as agent for Dance Chicago, John Schmitz, Founder and Artistic Director, (hereinafter referred to as "Artist"), and the Orland Park Arts Commission (hereinafter referred to as "Sponsor").

Sponsor hereby engages the services of Artist to provide a performance described as follows:

1 full-length performance with multiple dance companies on November 3, 2012, commencing at time ~~8:30~~ 10:30 pm and continuing until approximately 10:30 pm at Carl Sandburg High School Performing Arts Center.

Artist shall provide copy (including program outline and biographical information) suitable for inclusion in a press release. Materials will be sent in a timely way for arrival at the Sponsor's facility before the performance date.

Artist shall provide copy of the complete program, program notes, and biographical information suitable for inclusion in a house program. Materials will be sent in a timely way for arrival at the Sponsor's facility 10 days before the performance date.

All materials provided by Artist in compliance with the above two paragraphs shall be the property of the Sponsor. The Sponsor will bear all costs associated with reproduction and distribution of press and house programs beyond what is provided by the Artist.

Sponsor agrees to furnish Artist with details of parking and loading for the production.

Sponsor agrees to furnish Artist with their technical director contact to aid in executing the Dance Chicago lighting plot. Artist will furnish production stage manager, lighting director and sound director. Adequate supporting personnel to support and execute the show shall be provided by the Sponsor.
