Mr. Pigatto stated the plan for his new home is between 4,000 and 5,000 square feet. The developer is putting in a model home that is about 3,200 square feet so it will be slightly bigger.

Commissioner Schussler commented on no neighbors to the west and it being a great location. (refer to audio)

Commissioner Nugent asked if the house will be on what was effectively 2 lots or one side.

Mr. Pigatto responded the plan is to straddle both lots.

Commissioner Nugent commented on not being able to divide the lot.

Commissioner Zomparelli made a statement about the size of the lot and combining the 2. (refer to audio)
