



**ADDENDUM C TO THE TASTE OF ORLAND PARK TENTS, TABLES AND OTHER RENTAL
EQUIPMENT, DATED APRIL 1, 2024, AMENDED SEPTEMBER 23, 2024, AMENDED
AUGUST 4, 2025,
BETWEEN
THE VILLAGE OF ORLAND PARK AND TENT EVENTS CHICAGO**

WHEREAS, on April 1, 2024, a certain Agreement between the VILLAGE OF ORLAND PARK (hereinafter referred to as “Village”) and Tent Events Chicago, Inc(hereinafter referred to as “Consultant”) for the performance of certain professional services for the Village in connection with Taste of Orland Park Tents, Tables & Other Rental Equipment (hereinafter referred to as the “Project”, the “Work”, or the “Services”) was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, on September 23, 2024, a certain Agreement between the Village and the Consultant for the Taste of Orland Park Tents, Tables and Other Rental Equipment was previously amended (hereinafter referred to as the "Addendum A"); and

WHEREAS, on August 4, 2025, a certain Agreement between the Village and the Consultant for the Taste of Orland Park Tents, Tables and Other Rental Equipment was previously amended (hereinafter referred to as the "Addendum B"); and

WHEREAS, the Village wishes to modify SCOPE OF WORK, CONTRACT DOCUMENTS.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum C and the Agreement, the provisions of this Addendum C shall control.
2. **SECTION 1: SCOPE OF THE WORK** of said Agreement shall be amended to include the “Scope of Work” as set forth in Consultants Proposal dated July 16, 2026, for the rental of additional equipment (tents, weights, lights, tables, chairs) for the 2026 Taste of Orland Park.
3. **SECTION 2A: COMPENSATION** in said Agreement shall be amended to strike the “not-to-exceed amount of \$19,628.00 for FY2026” and replace with a new not-to-exceed amount of \$57,847.00.00 including \$2,944.20 of contingency. The FY2026 contract amount was increased by \$35,274.80.
4. **SECTION 3: THE CONTRACT DOCUMENTS** of said Agreement shall be amended to include Addendum C, dated August 3, 2026.
5. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
6. This Addendum C may be executed in two or more counterparts, each of which taken together shall constitute one and the same instrument.

This Addendum C made and entered into effective the 3rd day of August, 2026, shall be attached to and form a part of the Agreement dated the 1st day of April, 2024, amended September 23, 2024, amended August 4, 2025, and shall take effect upon signature below by duly authorized agents of both parties.
