This notification is to inform you that on September 17, 2018, the Village of Orland Park Board of Trustees approved exercising our option to extend the contract dated March 24, 2016 for 2019 and 2020 at a cost of Twenty-Five Thousand and No/100 (\$25,000.00) Dollars per SECTION 4: Term of the Contract. Based on your letter dated August 29, 2018, we understand that the show will be reduced by four (4) minutes to approximately 19-21 minutes in length due to the increased cost of fireworks.

Dear Ray,

As I had explained to you, with the price increases that we have incurred from our suppliers for 2019, it would cost you \$28,800 to duplicate the show we did this year. If you are unable to increase your budget, but you want to maintain the same quality and intensity of the show, we would have to cut approximately four minutes off the length of the show.

As you are probably aware, the majority of all the fireworks produced in the world come from China. The government of China has decided to eliminate over half of their manufacturers, which leaves the existing ones in a much greater demand. This has put the existing manufacturers in the position of being able to raise their prices.
