RE:        Extending term thru 2012

1.     In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2.     In **SECTION 1: THE CONTRACT DOCUMENTS**, of said Agreement, the words "The Proposal dated January 27, 2012, to the extent it does not conflict with this contract" shall be added to the end of the section after "The Proposal dated December 21, 2010."
3.     In **SECTION 4: TERM OF THE CONTRACT**, of said Agreement, the date "January 1, 2011" shall be stricken and replaced with "January 1, 2012." Both dates listed as "December 31, 2011" shall be stricken and replaced with "December 31, 2012."
4.     All of the other terms, covenants, representations and conditions of said Agreement, not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
5.     This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum, made and entered into effective the **13th day of March, 2012**, shall be attached to and form a part of the Agreement dated May 19, 2010, amended April 20, 2011, and shall take effect upon signature below by duly authorized agents of both parties.
