The Village of Orland Park, Illinois ("VILLAGE") and Austin Tyler Construction, Inc.
("CONTRACTOR")

WHEREAS, on May 19, 2015, a certain Agreement regarding 2015 Road Improvement Program between the Village and the Contractor was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, the Village wishes to increase the SCOPE OF WORK.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2. In **SECTION 2: SCOPE OF THE WORK AND PAYMENT** of said Agreement the following shall be stricken in its entirety:

TOTAL: an amount not to exceed Five Million Seventy Five Thousand Seven Hundred Ninety-Six and 90/100 (\$5,075,796.90) Dollars

And replaced with:

TOTAL: an amount not to exceed Five Million Five Hundred Seventy Thousand Seven Hundred Ninety-Six and 90/100 (\$5,570,796.90) Dollars

3. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
4. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.
