

## ADDENDUM B TO PAVEMENT MARKING SERVICES 2024-2026, DATED MARCH 18, 2024, AMENDED JUNE 18, 2024, BETWEEN

## THE VILLAGE OF ORLAND PARK AND PRECISION PAVEMENT MARKINGS INC.

WHEREAS, on March 18, 2024, a certain Agreement between the VILLAGE OF ORLAND PARK (hereinafter referred to as "Village") and Precision Pavement Markings Inc. (hereinafter referred to as "Contractor") for the performance of certain professional services for the Village in connection with Pavement Marking Services 2024-2026 (hereinafter referred to as the "Project", the "Work", or the "Services") was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, on June 18, 2024, a certain Agreement between the Village and the Contractor for the <a href="Project/Work/Services">Project/Work/Services</a> was previously amended (hereinafter referred to as the "Addendum A"); and

WHEREAS, the Village wishes to modify SCOPE OF WORK, CONTRACT DOCUMENTS, and PAYMENT.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

- 1. In the event of any conflict or inconsistency between the provisions of this Addendum B and the Agreement, the provisions of this Addendum B shall control.
- 2. **SECTION 1: SCOPE OF THE WORK** of said Agreement shall be amended to include the "Scope of Work" as set forth in Contractor's Invoice #5368, dated October 21, 2025.
- 3. <u>SECTION 2: COMPENSATION</u> in said Agreement shall be amended to strike the words "not-to-exceed amount of \$75,000.00 for FY 2025" and replace with the words "not-to-exceed amount of \$77,837.07 for FY 2025." Contract increased by \$2,837.07 for FY 2025.
- 4. **SECTION 4: THE CONTRACT DOCUMENTS** of said Agreement shall be amended to include Addendum B, dated November 17, 2025.
- 5. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
- 6. This Addendum B may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum B, made and entered into effective the 17<sup>th</sup> day of November, 2025, shall be attached to and form a part of the Agreement dated the 18<sup>th</sup> day of March, 2024, amended June 18, 2024, and shall take effect upon signature below by duly authorized agents of both parties.
