ADDENDUM A TO Snow Services, DATED November 12, 2021

BETWEEN

THE VILLAGE OF ORLAND PARK AND CONSTRUCTION CONCEPTS OF ILLINOIS INC.

WHEREAS, on November 12, 2021, a certain Agreement between the VILLAGE OF ORLAND PARK (hereinafter referred to as "Village") and Construction Concepts of Illinois Inc. (hereinafter referred to as "Contractor") for the performance of certain professional services for the Village in connection with Snow Services (hereinafter referred to as the "Project", the "Work", or the "Services") was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, the Village wishes to modify PAYMENT.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2. **SECTION 2: COMPENSATION** in said Agreement shall be amended to change the "Contract Price" to \$26,000.00.
3. **SECTION 4: THE CONTRACT DOCUMENTS** of said Agreement shall be amended to include Addendum A, dated April 22, 2022.
4. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
5. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum, made and entered into effective the 22 day of April, 2022, shall be attached to and form a part of the Agreement dated the 12 day of November, 2021, and shall take effect upon signature below by duly authorized agents of both parties.
