

### Ordinance: #...

Pursuant to Orland Park IL Code of Ordinances, XXX. The owner of the motor vehicle is liable for payment of a civil penalty in the amount of \$100 if the owner's vehicle enters an intersection monitored by a photographic traffic signal enforcement system against a red light in violation of State law. Recorded images are evidence of a violation of a red light enforcement system.

Failure to pay the civil fine or to contest liability within 30 calendar days of the date on this notice is an admission of liability in the full amount of the civil fine assessed and may result in an additional late fee penalty and the possible loss of your right to a hearing. In addition, you may be subject to formal collection procedures including, but not limited to, being reported to a credit reporting agency, and a civil lawsuit.
