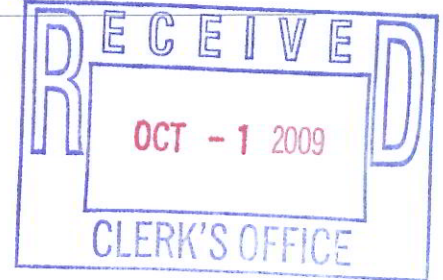

PROPOSAL

Proposal to repair a sewer in Orland Park as follows:

7919 Sycamore Drive

- Expose existing sanitary sewer main on west side of Primrose Lane, approximately 12' deep
- Replace existing 6" clay tile sewer stub with new 6" ABS S.D.R. 23.5 pipe from sewer main to property line, 1' west of sidewalk
- No clean out tee on sewer service
- Park Plumbing to provide ditch box/shoring, as required
- Remove (2) sections of public walk
- Remove clay tile hub from sewer main, install new Fernco tapping saddle

15165 Primrose Lane

- Replace existing 6" clay tile sewer service, with new 6" ABS S.D.R. 23.5 pipe from main to "curb line" of Primrose Lane
- No cleanout tee, curb removal or street cut for this stub
- Remove clay tile hub from sewer main, install new Fernco tapping saddle
- Bed all new excavation with ¾" stone, trench backfill at sidewalk cut

EXCLUSIONS

- No permit fee included in this proposal
- Village of Orland Park to provide all ¾" stone for backfill
- Village of Orland Park shall provide dump truck and driver for removal of spoil from site, trucks shall be loaded by Park Plumbing employees and equipment
- Village of Orland Park supplied material, trucks and driver – must be provided at an "on time" basis
- No ground repair or sidewalk replacement included in this proposal

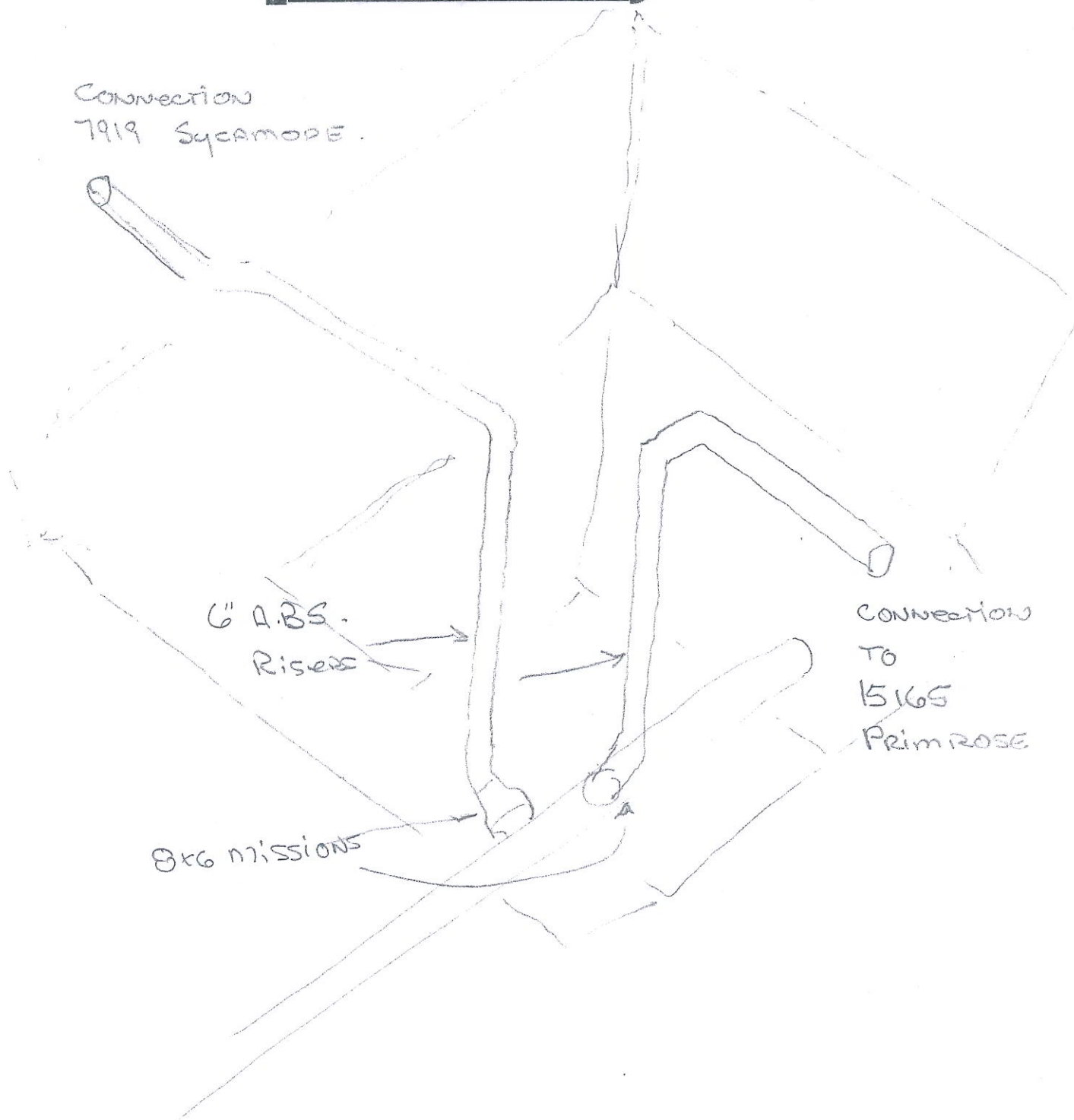

Emergency Sanitary Sewer Repair - Proposal

History

The resident at 7919 Sycamore Drive experienced a sewer backup within their service line. Per Village of Orland Park policy, the location of the blockage was identified within the right-of-way of their side yard. The depth of the sanitary main in this area is twelve

(12) feet and is beyond the reach of our equipment.

Requests for Proposal were solicited from Airy's, Inc. of Tinley Park, Illinois, and Park Plumbing of Orland Park, Illinois. Airy's proposed doing the work for \$7,362 and Park Plumbing submitted a proposal for \$6,350. Therefore, it is recommended that the proposal from Park Plumbing of Orland Park, Illinois, be accepted for completing the work.

Because the resident has very limited sanitary service, the work will be completed on an emergency basis on September 15, 2009, by Park Plumbing - the low bidder.

On September 14, 2009, this item was reviewed and approved by the Public Works and Engineering Committee and referred to the Village Board for approval.

Financial Impact

Funds are available in Sewer Lines Repairs and Replacements Account #031-6003-433.43-80 to cover the cost of this work.

Recommended Action/Motion

I move to approve accepting the proposal from Park Plumbing of Orland Park, Illinois, for the repair of the sanitary service line at 7919 Sycamore Drive for an amount not to exceed \$6,350;

And

Approve authorizing the Village Manager to execute the proposal/contract.
