All local agencies are required to follow the Illinois Department of Transportation (IDOT) Motor Fuel Tax procedures. This includes entering into a state/local intergovernmental agreement and obtaining department plan approval. The funds are not grants to be given directly to local agencies. The department will reimburse local agencies for the project cost after a formal construction contract for the specific project(s) has been executed. If the local agency wishes to downsize the project, based on the ERP funding, that will be allowed.
