WHEREAS, on May 16, 2017, a certain Agreement regarding Roof Replacement 2017 between the Village and the Contractor was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, the Village wishes to modify the SCOPE OF WORK.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2. SECTION 1: THE CONTRACT DOCUMENTS of said Agreement shall be amended to include "Addendum A dated June 15, 2017" and "Proposal dated May 4, 2017."
3. SECTION 2: SCOPE OF THE WORK AND PAYMENT of said Agreement shall be amended to include the following:

Deer Point Estates Park Pavilion, Deer Point Drive and Deer Creek, Orland Park, IL

 - Remove existing shingles
 - Install new underlayment
 - Install new metal roofing
 - Replace/repair missing wood fascia
 - Cover new fascia with aluminum to match existing
 - Haul away all debris
4. SECTION 2: SCOPE OF THE WORK AND PAYMENT of said Agreement shall be amended to include the following before "TOTAL":
Deer Point Estates \$5,760.00
5. SECTION 2: SCOPE OF THE WORK AND PAYMENT of said Agreement shall be amended to strike the following words "TOTAL: Twenty Seven Thousand Four Hundred Thirty and No/100 (\$27,430.00) Dollars" and replace with "TOTAL: Thirty Three Thousand One Hundred Ninety and No/100 (\$33,190.00) Dollars".
6. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
7. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.
