1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2. In **SECTION 10: MODIFICATION**, of said Agreement, the sentence "Per Addendum dated August 1, 2013, the CONTRACTOR is hereby authorized to perform additional work not to exceed Eight Hundred Ten Thousand and No/100 (\$810,000.00) Dollars for a total contract price not to exceed Three Million Five Hundred Six Thousand Eight Hundred Forty-Four and No/100 (\$3,506,844.55) Dollars at the stated rates in SECTION 2 above."
3. All of the other terms, covenants, representations and conditions of said Agreement, not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
4. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum, made and entered into effective the **2nd day of August, 2013**, shall be attached to and form a part of the Agreement dated the 4<sup>th</sup> day of June, 2013 and shall take effect upon signature below by duly authorized agents of both parties.
