

AGREEMENT GRANTING AND CONVEYING CROSS ACCESS EASEMENT

This Agreement, made by and between ST. GEORGE CORPORATION and PALOS COMMUNITY HOSPITAL, each an Illinois not-for-profit corporation, the owner of Lot _____ of the _____ Subdivision, Cook County, Illinois, shown on the Plat of Subdivision attached hereto as Exhibit A and incorporated herein by reference, and the VILLAGE OF ORLAND PARK, an Illinois home rule municipal corporation (“VILLAGE”), the owners of Lot _____ of the _____ Subdivision located in Orland Park, Cook County, Illinois, shown in Exhibit A, attached hereto and incorporated herein by reference.

WHEREAS, ST. GEORGE desires to grant VILLAGE, and VILLAGE desires to grant ST. GEORGE, pursuant to the terms and conditions set forth herein, cross-access easement rights on and over the property shown in Exhibit A as “Cross Access Easement” (said Exhibit A is attached hereto and incorporated herein by reference), for the purpose of allowing vehicular traffic to cross over the cross easement area (legally described in Exhibit B hereto) and further depicted in Exhibit C (hereto) from Lot ___ of the _____ Subdivision to Lot ___ of the _____ Subdivision and from Lot _____ of the _____ Subdivision to Lot 1 of the _____ Subdivision shown in Exhibit A attached hereto.

THEREFORE, in consideration of the foregoing and the receipt of TEN DOLLARS (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged and the further covenants contained herein, it is agreed between ST. GEORGE and VILLAGE as follows:

1. ST. GEORGE grants to VILLAGE and its respective successors and assigns a perpetual non exclusive cross access easement over the property depicted in Exhibit A as “Access Easement”, and legally described in Exhibit B hereto, for the purpose of vehicular traffic traveling from Lot _____ of the _____ Subdivision to Lot _____ of the _____ Subdivision and from Lot _____ of the _____ Subdivision to Lot _____ of the _____ Subdivision as shown in Exhibit A attached hereto.

2. VILLAGE grants to ST. GEORGE and its perspective successors and assigns a perpetual non-exclusive cross access easement over the property depicted in Exhibit A as “Access Easement”, and legally described in Exhibit B hereto, for the purpose of vehicular traffic traveling from Lot _____ of the _____ to Lot _____ of the _____ Subdivision and from Lot _____ of the _____ Subdivision to Lot _____ of the _____ Subdivision as shown on Exhibit A attached hereto.

3. This reciprocal grant of easement will run with the land for the term of the easement and will be binding on and will inure to the benefit of the parties hereto, their

heirs, successors, and assigns. This Agreement may be recorded by VILLAGE at VILLAGE's expense.

4. Delivery of a copy of this agreement, or any notice provided for in it, will be deemed to be complete if and when personally delivered or when deposited in the United States mails, certified mail, postage prepaid, return receipt requested, and addressed to the parties hereto at the below stated addresses:

5. The parties hereto shall routinely consult with each other concerning the need to maintain, repair, replace or reconstruct the cross-access easement areas as described herein and the costs for such maintenance, repair, replacement or reconstruction shall be borne by the parties as follows:

6. This Agreement shall not affect any real property not specifically referred to herein.

7. If any provision of this Agreement, or portion thereof, or the application thereof to any person or circumstances, shall, to the extent be held invalid, inoperative or unenforceable, the remainder of this Agreement, or the application of such provision or portion thereof to any other persons or circumstances, shall not be affected thereby; it shall not be deemed that any such invalid provision affects the consideration for this Agreement; and each provision of this Agreement shall be valid and enforceable to the fullest extent permitted by law.

8. This Agreement shall be governed, construed and enforced in accordance with the laws of the State of Illinois.


9. Nothing in this Agreement shall be construed to make the parties hereto partners or joint venturers or render any of said parties liable for the debts or obligations of the other.


10. This Agreement may be executed in several counterparts, each of which shall be deemed an original and all of which together shall constitute one and the same document.

11. The parties hereto acknowledge that this Agreement shall be recorded in the Office of the Recorder of Deeds of Cook County, Illinois.

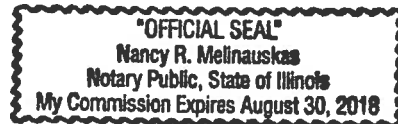
