WARRANTY INFORMATION

Law Weapons & Supply warrants the following with respect to rifles manufactured by RGUNS or bearing the RGUNS label:

- 1. That the Product is free from defects in material and workmanship and when used in accordance with the user manual supplied with the rifles.
- 2. That upon payment in full for the Product, they shall be rendered free and clear of all liens, claims or encumbrances of any kind.
- 3. The Product warranty shall extend to the original purchaser of the Product [Orland Park Police Department] for life, as long as the rifles are still the property of [Orland Park Police Department], [any transfer of ownership will void all warranties implied] are being used according to the original design parameters, and are defective in workmanship or material.
- 4. Law Weapons & Supply agrees to refurbish or replace such parts or rifles without charge, F.O.B. Point of Origin for the life of the product.
- 5. Buyer shall pay freight charges on the returned components covered under this warranty.
- 6. Any returned rifles must be handled via a return authorization from Law Weapons & Supply, or they will be refused.

- 7. Law Weapons & Supply will not be responsible for charges on any repairs or alterations of the rifles unless made with Law Weapons & Supplies prior written consent.
- 8. Warranty claims, which result from customer errors, failure to follow safe operational procedures or inadequate maintenance, will not be accepted.
- 9. Law Weapons & Supply will not be responsible for damage due to fire, wind, flood, intentional abuse, normal wear & tear or use beyond the design capacity of the product.
- 10. With respect to any products sold but not manufactured by RGUNS or Law Weapons & Supply or bearing the RGUNS /LWS label, Law Weapons & Supply will assign to purchaser all available manufacturer warranties.

Law Weapons and Supply represents, covenants and warrants to the Orland Park Police Department that any firearms that are to be traded in by the Orland Park Police Department pursuant to this proposal and any other agreement shall and will be sold and/or ownership transferred only to sworn law enforcement officers and/or to another law enforcement agency.
