**INSTALLATION COST:** The cost, if any, for installing the Equipment by Mainline will be shown on the invoice, if installation is required by Mainline and said installation is more than incidental to the delivery of Equipment. Buyer agrees to provide a secure location and safe working environment for the delivery and installation of Equipment.

**WARRANTY:** Seller warrants that new Equipment included in this sale to Buyer, if any, is eligible for all warranties and indemnities provided by the manufacturer.
