Rech Entertainment offers a full menu of entertainment services specializing in talent buying to full-scale concert production including back of house, event management and audio/visual services. Past productions produced by Rech include Aretha Franklin, the Zac Brown Band, BB King, Ringo Star and John Legend.

Robert Rech (Founder) is a 35-year veteran of the concert industry; Bob has continually made his mark on the profession. His expertise in talent buying as Entertainment Director of the Northern Lights Theater in Milwaukee, WI led to its reputation as one of the finest venues in the country, and to his as one of the premier talent buyers. In 2011, Bob produced the critically acclaimed Cheap Trick Dream Police show at the Northern Lights Theater, which featured the album played in full with a full 18-piece orchestra. Due to popular demand, the show returned the following winter. A vast number of up-and-coming stars, solidified superstars and legendary comedians took the stage at the Northern Lights Theater which culminated in Bob being named Casino Entertainment Executive of The Year in 2015.

Rech Entertainment proposes to perform the following professional services in securing national Artists as headliners for the Village of Orland Park's Centennial Park West Concerts, and Taste of Orland Park in 2025.

**SERVICES TO BE PERFORMED ON BEHALF OF THE VILLAGE OF ORLAND PARK
Contract, Rider and Advancing Services:**

1. Research, recommend and negotiate with National Artists capable of drawing at least 3,000 attendees based upon documented average ticket sales at outdoor venues, and those as requested by the Village of Orland Park to perform at Centennial Park West on specified dates in 2025.
2. Review and provide guidance to the Village in terms of acceptable terms for each Artist's contract and rider, ensuring the best possible costs for performance, travel, hospitality, backline, and all other financial commitments on behalf of the Village.

3. Advance and negotiate each rider and Artists' production requirements with Artists' tour manager(s) ensuring rider provisions are reasonable, cost effective and acceptable to the Village.
4. Determine, based on the rider advance, the Artists' buyout payment(s) and communicate to Village representatives at least six weeks prior to the concert date the buyout total for each Artist.
5. Build a positive reputation on behalf of the Village with the agent/s and artist/s.

Artist Hospitality

1. Hotel accommodations: For each Artist, consistent with agreed upon rider requirements, negotiate and confirm the number and type of rooms needed and forward to the Village contact. Submit the room list to the Village contact before the designated deadline.
2. Meals: Advance the Artists' dressing room hospitality requests, and provide shopping lists as mutually agreed upon per the contract advance and rider requirements.
3. Ground Transportation: Coordinate ground transportation with Village of Orland Park based upon the agreed contract advance and rider requirements.

The Village of Orland Park agrees to pay Rech Entertainment 10% of each Artist's guarantee performance fee for services as described above.
