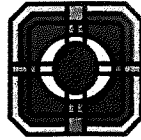

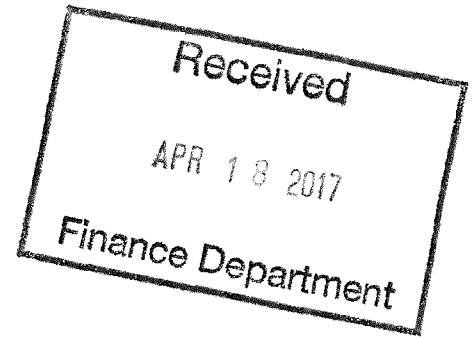

WHEREAS, on February 25, 2011, a certain Agreement regarding Window Washing 2011-13 between the Village and the Contractor was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, on March 17, 2014, a certain Agreement regarding Window Washing 2011-13 between the Village and the Contractor was amended (hereinafter referred to as the "Addendum A"); and

WHEREAS, the Village wishes to extend the term of the agreement for an additional three (3) years.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2. **SECTION 1: THE CONTRACT DOCUMENTS:** of said Agreement shall be amended to include "Proposal (email) dated February 20, 2017"
3. **SECTION 2: SCOPE OF THE WORK AND PAYMENT:** of said Agreement shall be amended to strike the following table:
