WE ARE PLEASED TO PROVIDE A PROPOSAL FOR THE ABOVE MENTIONED PROJECT, AND OUR COST FOR THE ELECTRICAL WORK IS AS FOLLOWS: **\$498,700.00**

THE FOLLOWING PERTAINS TO OUR PROPOSAL:

1. Install mobile generator and connect for temporary use.
2. Disconnect existing 500kw generator feed cables and control cables.
3. Remove and dispose of fluids.
4. Remove electric heaters and power vent units.
5. Remove enclosure, shrouds and exhaust stack.
6. Crane generator off pad, remove from site and dispose.
7. Inspect and test all cables for damage and integrity.
8. Furnish new diesel 500kw generator with sound attenuate weatherproof enclosure.
9. Crane new 500kw generator on to existing pad and anchor.
10. Furnish and install new tap box on feed cables.
11. Furnish and install (3) 4" sealtite connections to generator.
12. Terminate feed cables on new generator.
13. Furnish and install (2) 1" sealtite connection for controls.
14. Terminate control cables on new generator.
15. Furnish and install (2) led vaporproof lights.
16. Disconnect existing 1600A transfer switch and remove.
17. Furnish and install custom buss detail and blister for transfer switch.
18. Furnish and install new 1600A transfer switch.
19. All work performed during normal working hours.
