WHEREAS, on October 28, 2010, a certain Agreement regarding the Smart Energy Fund Program between the VILLAGE and the OWNER/LESSEE was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, the OWNER/LESSEE wishes to modify the Agreement;

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2. Section 1 of the Smart Energy Fund Agreement for Paddy B's of Orland Park, dated October 28, 2010, is amended to remove the following agreed upon equipment:

Refrigerator Manufacturer Turbo Air (Reach-In)

- 27 inch (L) x 30 inch (W) x 78 inch (H);
- Two section model (TSR-23SD);
- Cost: \$1,438.65;
- Energy Star Qualified

Solid Door Refrigerators

- 29 inch (L) x 28 inch (W) x 78 inch (H);
- Model Number M3R24-1
- Cost: \$2,900.00;
- California Energy Commission Certified

And replace with the following energy efficient systems:

Two (2) Solid Door Refrigerators

- 29 inch (L) x 28 inch (W) x 78 inch (H);
- Model Number M3R24-1;
- California Energy Commission Certified;

One (1) Turbo Air M3F24-1

- 28.7 inch (L) x 30.9 inch (W) x 82 inch (H);
- Model Number M3F24-1;




