2013-0302 Strategic Planning Workshop

Village Manager Grimes gave a brief introduction of what the purpose of this meeting was about and then introduced Mark Thorsby, Vice President of SmithBucklin and facilitator of this meeting.

Previously distributed to the Board and Commissioners were highlights from the April 26, 2013 Strategic Planning Survey summary (**EXHIBIT A**).

Facilitator Thorsby stated that at today's workshop, the Board and Commissioners together would be brainstorming in small groups.

The first exercise was for the group to brainstorm on the strategic issues contained in the survey summary. From that list, the group would break the many suggestions down to three (3) important issues they believed were important to pursue for the Village of Orland Park. Three (3) small groups were selected and after approximately 30 minutes this is what the groups reported:

Group 1: Economic Development, Quality of Life, Village Communication

Additional:

Job Creation, Maintenance, Business Diversity, Retail Vacancies, Public Safety, Bike Paths, Open Lands, Parks, Roads, Educate Public, Utilize Assets, Traffic Management, Residence Stability and Longevity, Commuter Service (trains), Safety retail, Downtown Development, Financial Soundness, Infrastructure Maintenance, Affordable housing, Improve Community Feeling.

Group 2: Downtown Economic Development, Economic Diversity, Safety (Mall and Personal)

Additional:

Personal Property Maintenance, Improve Communication with Residents, Invest in Business Community, Corporate Development - I-80/159th Street, Increase Entertainment Opportunities.

Group 3: Protect Existing Revenue Streams, Communication, Economic Development

Additional:

Maintain Services, Community Engagement, Safety, Education, Better Understanding Customer, Demographics (aging population).

Three (3) different small groups were then formed to report what trends will remain in the Village for the next 24 to 36 months (future issues). To list these trends from high to low. After approximately 45 minutes this is what the groups reported:
