MAXIA: I am an Orland Park resident this is our 4th year. I think, given the opportunity we will be a reflection of community and we will do Orland Park proud to come back to Orland. We are quiet, we will not be there in the evenings, and

RICCARDO: We have about a 50/50 mix right now, so our kids classes are earlier during the day and the adult classes start about 7:00PM.

STEPHENS: It doesn't appear that there will be any parking problems there due to the hours of use so I don't have any problem with this.
