BMO Harris Bank N.A. (BMO) and the Village of Orland Park (the "Village") are entering into 3 year contract from June 1, 2020 through May 31, 2023. BMO agrees to guarantee the per unit service fees quoted, with the exception of the federally mandated expenses (i.e. "Balance Admin Charges"), for the first 2 years. At the beginning of the 3rd year, June 1, 2022, BMO has the option to increase costs by no greater than a CPI percentage amount of the Village's fee structure.

All prices and services quoted are based on the Village's current services. Any service not quoted within this proposal will be subject to a pricing review and will be an incremental cost to the Village. We have strived to provide comprehensive pricing, including services that might occur. Given unit pricing is fixed for a period of time during the contract, if any of our assumptions are incorrect (or if additional services are requested or occur in the normal course of business) we may need to review and charge for services not included.

Please note, the ECR (Earnings Credit Rate) and Interest Rates will be reviewed as market conditions change and BMO reserves the right to change rates at any time.

This Contract will be effective as of June 1, 2020 when executed by both parties.
