Dear Mr. Wokurka,

Excel Electric, Inc. proposed the following scope and cost for the replacement of the secondary service conduit and conductors for the Village Hall building:

- Undermine existing ComEd transformer pad and install (2) 4" PVC conduits from transformer to foundation wall during normal working hours.
- New conduit excavation and backfill included.
- Removal of one section of sidewalk included. Sidewalk area to be backfilled with compacted stone. Remainder of trench to be backfilled with removed spoils.
- New copper 600MCM cable with XHHW insulation to be installed on a Saturday.
- Work to be coordinated with ComEd.


