WHEREAS, on October 21, 2014, a certain Agreement regarding Materials Loading and Hauling Services between the Village and the Contractor was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, on June 25, 2018, a certain Agreement regarding Materials Loading and Hauling Services between the Village and the Contractor was amended (hereinafter referred to as the "Addendum A"); and

WHEREAS, the Village wishes to extend the term of the agreement.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
2. **SECTION 1: THE CONTRACT DOCUMENTS** of said Agreement shall be amended to include "Addendum B dated May 5, 2020" and "KLF Commitment Letter dated April 1, 2020"
3. **SECTION 2: SCOPE OF THE WORK AND PAYMENT** of said Agreement shall be amended to strike "2016-2019" in the table and replace with "2016-2021"
4. **SECTION 4: TERM OF THE CONTRACT** of said Agreement shall be amended to strike the section in its entirety and replace with the following in its entirety:  
  
"**SECTION 4: TERM OF THE CONTRACT:** This Contract and the WORK shall commence on the date of its execution. The WORK shall continue expeditiously from that date until final completion. This Contract shall terminate upon completion of the WORK or October 31, 2021, whichever occurs first, but may be terminated by either of the PARTIES for default upon failure to cure after ten (10) days prior written notice of said default from the aggrieved PARTY. The VILLAGE, for its convenience, may terminate this Contract with thirty (30) days prior written notice."
5. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
6. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.




