We propose to supply all necessary personnel; supervision, materials, equipment & disposal to properly provide the following:

Asbestos Mastic/Floor Tile Removal

- Properly Remove and Dispose of up to 2050 square feet of carpet/floor tile/black mastic from within the open office area
- The work will be completed in one (1) to two (2) shifts and once work starts the work area will not be accessible by others.
- 10 Day Cook County Notification/Permit
- 10 Day IEPA Notification
- Final Air Clearance

Total: Eleven Thousand Forty Dollars (\$12,540.00)

This project includes submittal of all required Notifications (IEPA, IDPH 10-Day Notification and Chicago) and permits (as applicable). This requires an initial payment of \$5,500.00 and the balance will be due upon completion of the work.

In the event the stage is to be removed an additional cost of \$1,800.00 will be incurred.


- * EPI will not be responsible for any additional permits.

- * The work will be performed by union laborers licensed by the IDPH in accordance with NESHAP regulations.
- * This Proposal does not include removal or moving of any equipment (i.e. shelves/racks) left in the space.
- * All matter is guaranteed to be as specified. All work to be completed in a workman like manner according to standard practices. Any alteration or deviation from above specifications involving extra costs will be executed only upon written orders, and will become an extra charge over and above the estimate. All agreements contingent upon strikes, accidents, or delays beyond our company. Owner is to carry necessary insurance.
- * EPI shall invoice Client for the fees and costs that are due or will become due in accordance with this proposal. Client shall pay all such invoiced amounts within 30 days of the date of the corresponding EPI invoice. All fees are accountable and payable in U.S dollars. In the event of a late payment by Client, EPI shall be entitled to assess an additional late payment fee for such instance at an amount of two percent of such payments per every thirty days or portion thereof for which the invoice payment is late or the maximum amount permissible by applicable law.
- * A Report will be prepared that documents all aspects of the work performed.


